**SUMMARY & BACKGROUND** 

On March 11, 2021, the President signed into law the American Rescue Plan Act of 2021 (ARP). ARP makes available \$122.8 billion nationally in a third round of Elementary and Secondary School Emergency Relief (ESSER) funds. New York State has been allocated nearly \$9 billion under the ARP Act's Elementary and Secondary School Emergency Relief (ESSER) Fund. The ARP Act requires that a minimum of \$8.09 billion (90 percent) be allocated to LEAs, including charter schools and Special Act School Districts that are LEAs. Pursuant to the terms of the ARP Act, LEA allocations have been calculated using the relative shares of grants awarded under Title I, Part A of the ESEA for the most recent federal

fiscal year (2020). Each eligible LEA's ARP-ESSER allocation may be found HERE.

Under section 2001(d)(2) of ARP Act of 2021, each State Educational Agency (SEA) must make ARP-ESSER allocations to LEAs in an expedited and timely manner and, to the extent practicable, not later than 60 days after the SEA receives its ARP-ESSER funds. The first portion of ARP-ESSER Funds was awarded to states on March 24, 2021, and 60 days from that day is May 24, 2021. The U.S. Department of Education (USDE) has taken the position that an SEA makes allocations when it authorizes the LEA to begin to obligate funds in accordance with its needs. To enable New York State's LEAs to begin to obligate ARP-ESSER funds by USDE's May 24, 2021 deadline, the application for LEA 90% base

• ARP-ESSER Application - Part 1: The first step was for each LEA to submit signed assurances to NYSED by May 24, 2021. Upon receipt of signed LEA assurances, NYSED provided an email notice to the LEA of substantially approvable application status. Upon receipt of such

notice, LEAs were able to begin obligating their allocation of 90% base ARP-ESSER funds.

• ARP-ESSER Application – Part 2: The second step will be the submission of a full application and budget by the LEA. NYSED will issue a Grant Award Notice (GAN) to the LEA after the LEA's application is fully reviewed and approved by NYSED. Part 2 will address several of the

plan-related assurances an LEA must provide in Part 1 of the application process.

The ARP Act requires LEAs to reserve at least 20% of their 90% ARP-ESSER allocation to address learning loss through the implementation of evidence-based interventions, such as summer learning or summer enrichment, extended day, comprehensive afterschool programs, or extended school year programs, and ensure that such interventions respond to students' academic, social, and emotional needs and address the disproportionate impact of the coronavirus on economically disadvantaged students, children with disabilities, English learners, racial and ethnic minorities, migrant students, students experiencing homelessness, and children and youth in foster care. Title VIII of Division B of the CARES Act directs the Department to carry out the Education Stabilization Fund, of which the ARP ESSER funds are a part. Comments on the final plan will be received at the Board of Education meeting on August 25, 2021. Parents are in attendance at the Board of Education meetings.

In addition, district officials have held additional meetings with students, most recently on November 30, teachers and parents, most recently on December 2. In these meetings district officials review the use of funds to address the impact of the pandemic and receive inpurt from stakeholders on these plans.

Using the data collected as outlined in question 5 and the knowledge we have regarding individual student needs, funds will be used to create both an extended school day program and a summer learning program. Students will be grouped and provided instruction/support based on identified academic and/or social emotional needs.

Our extended school day and summer enrichment programs will be paid through other funding sources. The ARP-ESSER 2 funds in this grant will be used to support the costs associated with hiring additional teachers, teaching assistants and an instructional team leader to provide intensive support to support students to address loss learning.

In addition to the additional positions above, the district will also hire a teacher aide to provide more intense instruction in our elementary grades to assist in addressing loss learning.

Remianing funds will be used to

- Provide greater targeted support to those students who continue to struggle, in addition to the support outlined in question 5. This targeted support will follow Tier II and III of the RTI model
- In depth assessments, using multiple measures of individual student achievement and the identification of futther supports that may be needed
- Provide professional development opportunities to staff, based on current needs (technology, SEL, mitigating COVID-19 risks in the school community, etc.)
- · Purchase of cleaning products, as necessary
- · Purchase of technolgy related materials to support both in class instruction and remote instruction
- · Pre-planning work associated with the development of an extended school day program and summer enrichment program

The district will also use ARP-ESSER 2 funds to continue the emplyment of a high school math teacher. In addition, the district will contract with OHM BOCES to increase the amount of services provided by social workers, speech therapists and occupational therapists. These additional services are to support students with disabilities and address student social, emotional and mental health issues.

All interventions will be reviewed and modified on a continual basis (approx every 5 weeks), based on the individual student. BCS has restructued its RTI program to better identify student weaknesses and provide targeted support in a timely manner. The district is providing faculty with professional development on the RTI process, identifying students for RTI, data collection and its use to inform instruction. The District is utilizing two teachers who excel in math and ELA instruction to provide Tier I, II and III academic support, in conjunction with the instruction/support provided by classroom teacher and special education team. The district has increased the number of school counselors in order to better assess student's SEL needs, provide timely assitance and/or provide assitance accessing community resources.

Given that our student population is approximately 220 students, the interventions listed will be individually tailored to meet the needs of each student. This includes students from low income families, children of color and students with disabilities. The district does not currently have any students who are English Language Learners.
