Notice is hereby given the Board of School Trustees, Fort Wayne Community Schools (the "Owner"), Fort Wayne, Indiana and CME Corporation (Construction Manager" or the CMC) shall receive sealed bids from experienced and prequalified contractors at the Fort Wayne Community Schools, Maintenance and Operations Facility, Facilities Department, located at 1519 Catalpa Street, Fort Wayne, Indiana, 46802

Bids for each bid package shall be received from a single prime contractor.

Bids will be opened and read aloud immediately after the submission of proposals in the Facilities Training Room of Fort Wayne Community Schools, located at 1519 Catalpa Street, Fort Wayne, Indiana. Bids received after that time or in another location shall be returned to the bidder unopened.

The prequalification to get access to the contract documents including plans, specifications, bid forms, and instructions to bidders are available through the Construction Manager – CME Corporation, 7235 Vickburg Pike, Fort Wayne, IN 46804; contact Scott Kohler by phone at 260-745-0251. All plans, specifications, and addenda will be issued through Procore. A link will be provided to access all bidding documents.

Each bid shall be accompanied by a certified check, a cashier's check or a bid bond executed by a surety company which is authorized to do business in the State of Indiana, made payable to the CME Corporation and in an amount equal to five percent (5%) of the bid. In the event a bidder withdraws its bid or fails to execute a satisfactory contract within ten (10) days after the contract is awarded to such bidder by CME Corporation, CME Corporation may declare the certified check, cashier's check or bid bond forfeited to CME Corporation, as liquidated damages.

A bid may not be modified, withdrawn or cancelled by the bidder for sixty (60) days following the time and date designated for the receipt of bids without the consent of CME Corporation and the Owner.

CME Corporation and the Owner reserves the right to reject any and all bids or waive any or all informalities, irregularities and/or inconsistencies in, or with respect to, any or all bids. Performance and Labor and Material Payment Bonds in an amount equal to one hundred percent (100%) of the contract amount shall be required to be provided by the successful bidder to CME Corporation and the Owner no later than ten (10) days after the execution of such contract. Such bonds shall remain in full force and effect for a period of twelve (12) months after the date of Substantial Completion.
