# Lakewood High School one of 20 schools recognized for amplifying student voice

Lakewood School District is proud to announce that Lakewood High School is one of 20 schools around the state honored with the inaugural "Washington Schools on the Rise" award from the Association of Washington Student Leaders and the Association of Washington School Principals.

The award recognizes schools where students and their teachers collaborate to

improve culture and amplify student voice.

Student clubs are driven by student interests, allowing them to create spaces where they feel included. There is also a Belonging Advisory this year where students help create lessons for Advisory meetings. During a Real Talk webinar with parents, Principal Jeanette Grisham said, "They know that they're seen and their ideas are valued."



# Cougar Cabinet reflects on changes in their schools

Students in Cougar Cabinet reflected on the improvements they have seen at their schools this year. In its second year, Cougar Cabinet was comprised of 60 students in grades 4-12.

During monthly meetings, students built connections across schools and met with their school teams and administrators. While identifying areas for improvement, students also brainstormed ways to have an impact.



# Supporting mental health and well-being

While each student's well-being is important, not each student needs the same supports. Multi-Tiered Systems of Support (MTSS) provides differentiated support through universal screenings, data-driven interventions, and progress monitoring.

All of our students learn skills to help them recognize when they feel upset and what they can do to feel calmer. Strategies include deep breathing, taking a dance break, journaling, drawing a picture, or talking to a trusted adult. Through collaboration, teachers, counselors and families foster a supportive environment that promotes resilience and reduces stigma.

# LHS students contribute 3,600 volunteer hours

This year, members of the Lakewood chapter of the National Honor Society completed over 3,000 hours of volunteer community service!

In addition, American Sign Language Honor Society students contributed more than 600 hours of community service and/or outreach, which reflects service to deaf communities or spreading ASL awareness.

# Focus on safety for our families and community

Partners: Snohomish County Sheriff's Office and City of Marysville



Snohomish County Sheriff's deputies visited our elementary schools this year to evaluate traffic patterns and teach kids about some of their special equipment. They also brought cocoa to the middle and high schools for two "Cocoa with Cops" events.



City of Marysville Enhanced Pedestrian Safety Project:
The City of Marysville heard at Mayor Nehring's Coffee Klatch in June 2023 from school staff and parents about the great need for a safe walking path along 172nd Street NE (SR 531) for pedestrians. City staff worked with WSDOT approval to pave a wider asphalt shoulder and add a striped buffer zone and flexible delineator posts with reflectors between the pedestrian traffic.

# Supporting healthier communities

Lakewood received its third electric bus this year. In 2020, Lakewood received a grant from Washington Ecology to purchase three electric buses at a cost lower than diesel. Electric buses save money since there is no fuel, oil, or transmission to maintain. Bonus – students naturally speak more quietly.

While every student earns 24 credits to graduate, the pathways to earn those credits are not the same for every student. Each student works with their counselor on a High School & Beyond Plan beginning in middle school. Students and their counselors can refer back to the plan when choosing classes.

#### **Career/Technical Pathway**

Some students are interested in pursuing a Career/Technical Field (CTE) after graduation: Popular Career/Technical Education classes include CorePlus Construction, American Sign Language, Video Foundations, Animal Biology and Marketing. Students can also apply to take one or more classes at the regional Sno-Isle Skills Center (exp: aerospace engineering, auto repair, firefighting, dental assistant) or at the RAP (Regional Apprenticeship Pathways) program (construction, electrical and labor trades).

## **Military Pathway**

Students who want to pursue military service after graduation can meet the pathways requirement by meeting a minimum score established by the military on the ASVAB (Armed Services Vocational Aptitude Battery).

Program — to guarantee students admission to six four-year public universities in the state if they meet these two criteria:

- Maintain a minimum GPA of 3.0 or higher
- Complete, or are on track to complete, all the College Academic Distribution Requirements

# Lakewood High renews accreditation

During their fourth episode of "Real Talk with Lakewood Principals," Lakewood High School Principal Jeanette Grisham chatted with Superintendent Dr. Erin Murphy and Lakewood Middle School Principal Amanda Coté about the high school's accreditation process and the role of student voice in that process.

Adjudicators were impressed with the district's overall goal of making sure that each student feels a sense belonging. Students who feel engaged in school have better attendance and are more connected to academics. Students were able to talk about the progress they have seen in their school and the changes they have identified and implemented.

Dr. Murphy elaborated on the district's approach toward continuous improvement. Each school shares its improvement plan on its website and collaborates with staff, students, parents and community members to measure progress.


Cougar Creek and English Crossing Elementary Schools were honored with Washington School Recognition Awards for the 2022-2023 school year.



LWSD utilized approximately \$1.7 million from our reserve funds in 2023-24. LWSD will continue to work in the coming years to balance revenue with expenditures while maintaining a 10% fund balance as required by Board policy. Our priority remains to support our students, staff, and community effectively while maintaining fiscal responsibility.

# Bond refinancing will save taxpayers \$4.6 million

In March, Lakewood was able to refinance its 2014 bonds. By refinancing these \$30.5 million in bonds, interest payments will be reduced, which will save district taxpayers \$4.6 million in interest over the next nine years.

Lakewood will be eligible to refinance an additional \$10 million in bonds this fall. We have started the necessary process to move forward with the refinance, pending favorable market conditions.

# Citizen's Guide to the Budget

Lakewood School District appreciates the tremendous support we receive from our community taxpayers and partners. As a district, we strive to operate efficiently and to be good stewards of taxpayer dollars.

More than three-quarters of the General Fund budget will be spent directly on **school instruction**. This includes teachers, counselors, librarians, educational assistants, teaching supplies, materials, textbooks, instructional staff development, and extracurricular activities, all of which enrich the overall quality of classroom instruction.

**Support activities**, such as custodial, transportation, food services, maintenance, utilities, and insurance, amount to 14%.

**Central administration** makes up the remaining 11% of the budget. These expenses include development, coordination and evaluation of instructional programs by the superintendent and central office. Also included are business and human resources, supervision for nutrition services, maintenance and transportation, communications and legal costs.



The 2023-24 Citizen's Guide to the Budget is designed to build understanding of how Washington schools are funded and how we in Lakewood School District allocate these revenues. ### **AA3 BOND RATING CONVEYS CONFIDENCE**

During the bond refinancing process, LWSD was assigned an Aa3 rating by Moody's Investors Service. The Aa3 rating represents an independent stamp of approval concerning our financial practices and outlook. We are proud of this rating and the confidence it conveys.

On April 23, voters approved both the Replacement Educational Programs and Operations Levy and a new Capital Improvements and Safety Levy. Both levies will be collected in 2025-2028. Thank you for your support and for investing in a strong future for Lakewood!

The EP&O Levy makes up 14% of our general fund revenue and provides funding for people and programs districtwide.

# Capital Improvements and Safety Levy (2025-2028)

At its July 17 study session, the Lakewood Board of Directors reviewed a list of priorities for the Capital Improvements and Safety Levy: The list is based on the work of the Capital Facilities Advisory Committee, which met in 2023.

The tentative schedule includes:

#### 2024-25

- SAFETY: Fencing to improve security during school hours
- ENERGY EFFICIENCY: Replace aging LES boiler and HVAC system

#### 2025-26

- SAFETY: Secure exterior doors at LES and ECE
- SAFETY: Update LMS and ECE

fire alarm control panels and building communications system

- PRESERVATION: Replace aging LMS roof
- ACCOMMODATE GROWTH: Reconfigure LMS cafeteria

#### 2026-27

- SAFETY: Secure exterior doors at LMS
- PRESERVATION: Update electrical equipment at LES, LMS
- EFFICIENCY: Lighting and electrical fixture updates at LES, ECE, CCE, LMS

#### 2027-28


- SAFETY: Secure exterior doors at CCE
- PRESERVATION: Update hot water and heat pumps at ECE
