WHEREAS, the Louisiana legislature, at its 2005 1st Extraordinary Legislative Session, adopted legislation repealing the exemption formerly contained in La.R.S. 33:4574.1.1(E) to the occupancy tax that the Southwest Louisiana Convention and Visitors Bureau ("Bureau") is authorized to impose;

WHEREAS, that legislation has been sent to the Governor for signature, and it is expected that the Governor will sign the legislation;

WHEREAS, the Bureau wishes to amend its ordinances to reflect the repeal of that exemption; and

WHEREAS, the effective date of that amendment shall be January 1, 2006.


NOW, THEREFORE, conditional upon the legislation described above becoming law and effective January 1, 2006, the Bureau's ordinances hereby are amended as follows:
