## AN ORDINANCE AMENDING THE SOUTHWEST LOUISIANA CONVENTION AND VISITORS BUREAU'S ORDINANCES

WHEREAS, the Louisiana legislature, at its 2005 Regular Session, adopted Act 434 authorizing the Southwest Louisiana Convention and Visitors Bureau ("Bureau") to increase its occupancy tax and changing the computation of the occupancy tax on complimentary hotel rooms, complimentary motel rooms and complimentary camping facilities within Calcasieu Parish;

WHEREAS, the Bureau has amended its ordinances to reflect that increase and those changes; and

WHEREAS, the effective date of the amendment is August 1, 2005.

NOW, THEREFORE, the Bureau's ordinances hereby are amended as follows:

Sec. 1-02.1(a) of Division 1 of the Bureau's ordinances hereby is amended by deleting the phrase "three (3)" and by substituting in lieu thereof the phrase "four (4)".

Sec. 1-02.2 of Division 1 of the Bureau's ordinances hereby is amended by deleting the current text in its entirety and by substituting in lieu thereof the following language:

- (a) There hereby is levied, from and after October 1, 1998, a Tax on the occupancy of Complimentary Rooms for Hotels owned, owned in part, or operated, directly or indirectly, or any combination thereof, by a company which has, or which owns or owns in part, directly or indirectly, a company (1) which has a license to conduct gambling activities on a river boat pursuant to Chapter 4 of Title 27 of La. R.S. 27:41 et seq. or its successor provisions or (2) which has a license to conduct slot machine gaming activities pursuant to Chapter 7 of Title 27 of the La. R.S. 27:351 et seq. or its successor provisions.
- (b) The rate of the Tax shall be four (4) percent. The amount of Tax owed by a Hotel for each Complimentary Room shall be determined by multiplying the rate of the Tax by the maximum amount for lodging for which state government employees may be reimbursed for hotel expenses in the particular municipality or in the unincorporated area of Calcasieu Parish where the Hotel is located as such

maximum amount for lodging as established by the Commissioner of Administration pursuant to La. R.S. 39:231.

- (c) The Tax shall be collected from occupants by Dealers and shall be paid at the time and in the manner hereafter provided.
- (d) The Tax shall be in addition to all other taxes, whether excise, license, privilege or property taxes, levied by the Bureau.

Sec. 1-05(c) of Division 1 of the Bureau's ordinances hereby is deleted.

Sec. 1-05(c) of Division 1 of the Bureau's ordinances hereby is amended by inserting the following provision:

During any month, the Tax imposed by Sec. 1-02.2 shall not apply to complimentary occupancy up to thirty-five percent (35%) of the total monthly occupancy of a Hotel owned, owned in part, or operated, directly or indirectly, or any combination thereof, by a company which has, or which owns or owns in part, directly or indirectly, a company (1) which has a license to conduct gambling activities on a river boat pursuant to Chapter 4 of Title 27 of La. R.S. 27:41 et seq. or its successor provisions or (2) which has a license to conduct slot machine gaming activities pursuant to Chapter 7 of Title 27 of the La. R.S. 27:351 et seq. or its successor provisions.
