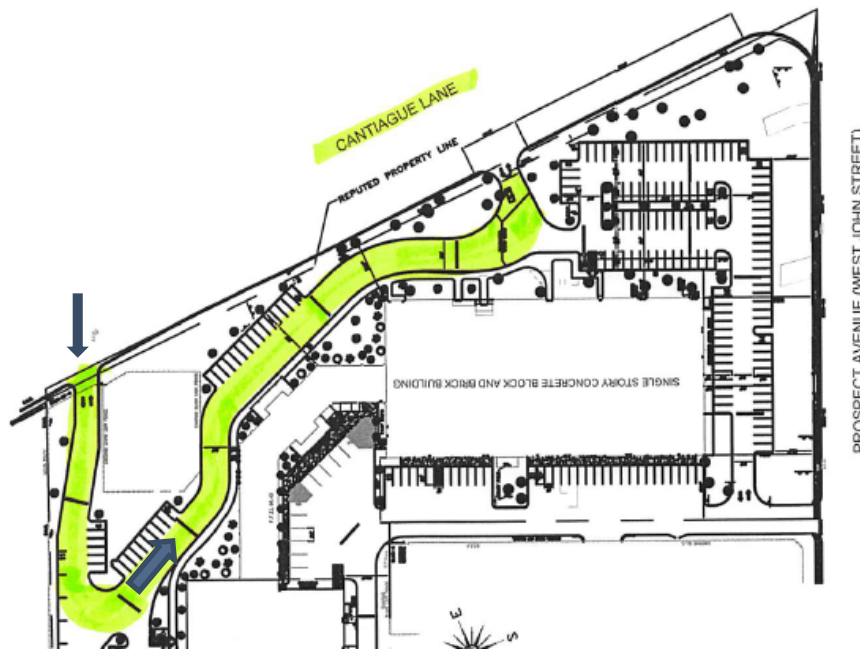


Arrival and Departure Procedures

ALL BUSES will drop-off students (both large and small buses) by entering from the Cantiague Lane entrance:

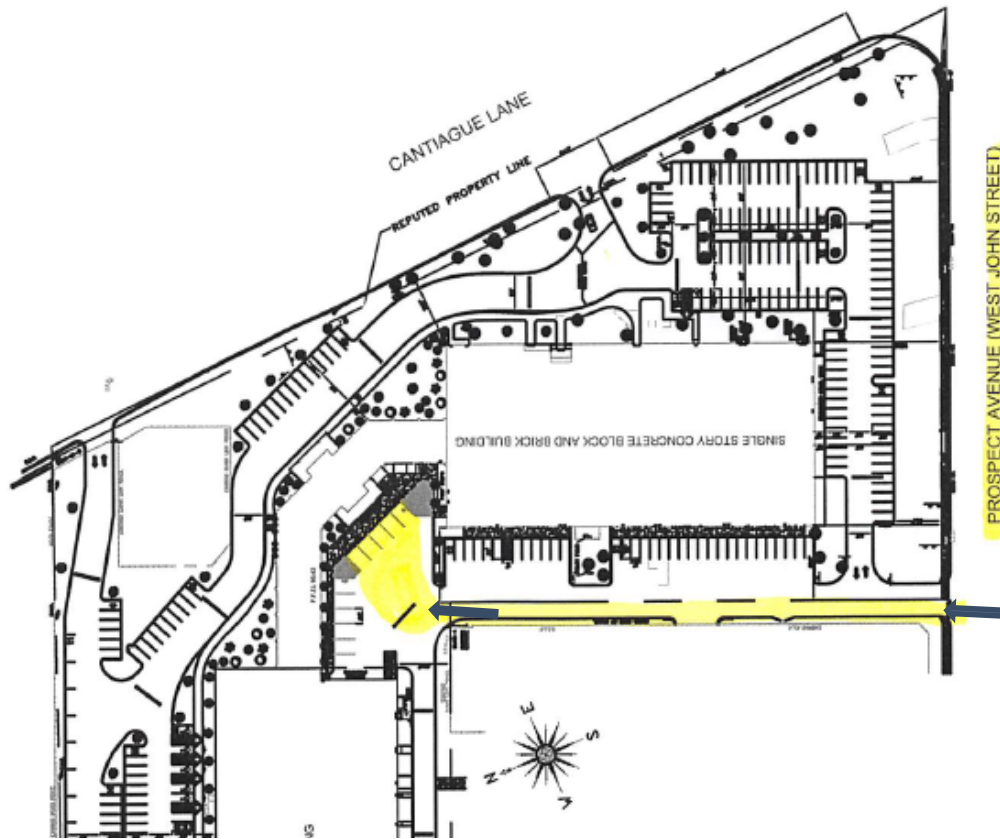

ALL Parents will drop-off their children by entering Bridge Street from Prospect Avenue:



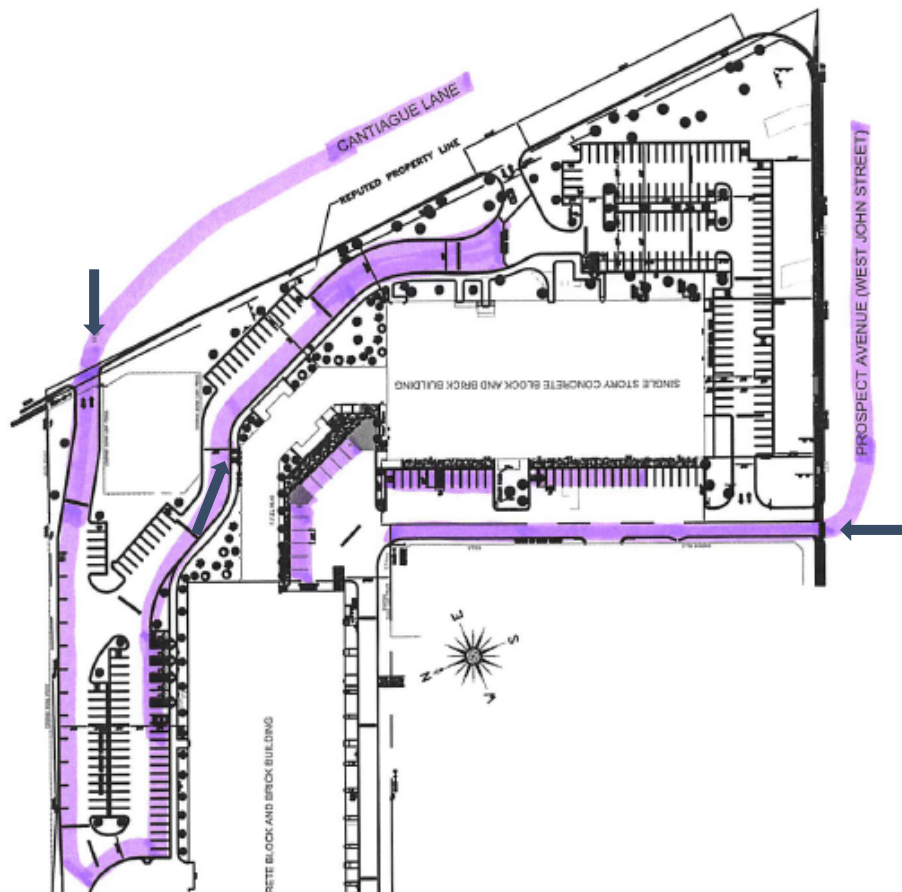
