Transportation Update

Dr. Duca presented an update on District transportation. He shared the challenges and solutions from the prior year. Dr Duca shared some proposed changes for the 2024 – 2025 school year. He discussed the goals and the findings supporting the proposed changes. Dr. Duca shared the NYS guidelines regarding walk distances to bus stops. He explained the changes supported efficiency and affordability.

Brian Sirianni reiterated the changes would not require less drivers, but would shorten run times. Mr. Sirianni stated it would make runs easier and safer for substitute drivers. He stated the shorter runs would allow mechanics to get back to their jobs when acting as relief drivers.
