

**POCATELLO/CHUBBUCK SCHOOL DISTRICT NO. 25
SUPPLEMENTAL LEVY ELECTION
RESOLUTION**

WHEREAS, in the opinion of the Board of Trustees of the Pocatello/Chubbuck School District No. 25, Bannock County, State of Idaho, there is a need for a two year Maintenance and Operation Supplemental Levy, as provided for in Idaho Code 33-802, in the amount of eight million two hundred and fifty thousand dollars (\$8,250,000.00) per year for the purpose of paying lawful expenses of maintaining and operating the schools of the District for the fiscal years 2025-2026 and 2026-2027; and

WHEREAS, the Board of Trustees has identified lawful expenses for the maintenance and operations of the schools as further described in the ballot question set forth in this Resolution, in accordance with Idaho Code, 33-802B.

NOW THEREFORE BE IT RESOLVED, by the Board of Trustees of the Pocatello/Chubbuck School District No. 25, Bannock County, Idaho, as follows:

- Section 1: That a Supplemental Levy Election is hereby called to be held on November 5, 2024, for the purpose of submitting to the qualified electors of the District, the question set out in the form of ballot appearing in Section 3 of this Resolution.
- Section 2: That said Election shall be conducted by the Bannock County Clerk pursuant to the election laws of the State of Idaho.
- Section 3: That the voting at said Election shall be by secret and separate ballot, and each ballot shall be prepared by the Bannock County Clerk and shall contain substantially the following information:

**SUPPLEMENTAL LEVY ELECTION
November 5, 2024**

The purposes for which the proposed levy revenues will be utilized and the approximate amount of levy funds to be allocated for each use are as follows:

Salaries and Benefits	\$4,725,000
Textbook and Supplies	\$925,000
Instructional Technology Software and Staffing	\$750,000
Extracurricular Transportation/Travel Expenses	\$600,000
Custodial Services	\$575,000
Extracurricular Salaries	\$475,000
School Resource Officers	\$200,000
TOTAL ANNUAL LEVY AMOUNT:	\$8,250,000/per year

Per Idaho Code 34-914 (1)(a): The proposed levy replaces an existing levy that is set to expire on June 30, 2025, and that currently costs \$113.07 per \$100,000 of taxable assessed value, per year, based on current conditions, and is not expected to change.

Shall the Board of Trustees of the Pocatello/Chubbuck School District No. 25, Bannock County, State of Idaho, be authorized and empowered to levy a two year Supplemental Levy, as permitted by law, in the amount of eight million two hundred and fifty thousand dollars (\$8,250,000.00) per year for the purpose of paying lawful expenses of maintaining and operating the schools of the District as stated above for the fiscal years 2025-2026 and 2026-2027?

- IN FAVOR OF AUTHORIZING A SUPPLEMENTAL LEVY AMOUNT OF \$8,250,000 PER YEAR FOR TWO (2) YEARS**
- AGAINST AUTHORIZING A SUPPLEMENTAL LEVY AMOUNT OF \$8,250,000 PER YEAR FOR TWO (2) YEARS**

Section 4: That the Clerk of the Board of Trustees of the District (“Clerk”) is authorized to convey to the Bannock County Clerk the forms of the Official Ballot of the Supplement Levy Election, appearing in Section 3 hereof, for election preparation and publication pursuant to Title 34, Idaho Code. The Clerk shall submit such forms to the Bannock County Clerk on or prior to September 1, 2024.

Section 5: That the Bannock County Commissioners shall act as the canvassing board pursuant to and in accordance with Title 34, Idaho Code, and will certify and convey the results to the District as provided therein.

Section 6: That if at the election a simple majority of the qualified registered electors of the District authorize such levy, the supplemental levy shall be approved and become effective in accordance with the provisions of Section 33-802, Idaho Code.
