7.1 Appointment of Bus Driver

Recommended Motion: RESOLVED, that the Board of Education of the Sauquoit Valley Central School District, pursuant to all applicable Civil Service rules and regulations, upon the recommendation of the Superintendent of Schools, does hereby appoint Edward Kurdziolek, to the position of bus driver contingent upon completion of all Article 19A DMV Regulations effective August 29, 2024 for a probationary period of 26 weeks to commence August 29, 2024 and to expire February 27, 2025.

Except to the extent required by the applicable provisions of Section 3012 of the Education Law, in order to be granted tenure as Director of Special Education you must receive composite or overall annual professional performance review ratings pursuant to Section 3012-c and/or Section 3012-d of the Education Law of either effective or highly effective in at least three (3) of the four (4) preceding years, and if the principal receives an ineffective composite or overall rating in the final year of the probationary period the principal shall not be eligible for tenure at that time.
