

Silver Creek Elementary School Parent Involvement Policy

General Expectations

Silver Creek Elementary School agrees to implement the following statutory requirements:

- 5. Silver Creek Elementary School will hold a flexible number of meetings at varying times; paid for with Title I funding as long as these services relate to parental involvement:

 - In situations that prevent parents from coming to the school for meetings, school personnel may arrange to meet parents at other mutually convenient times.

Silver Creek Elementary School will provide information about Title I programs to parents of participating children in a timely manner through the automated phone system, memos, newsletters, and the web page.

- (a) If requested by parents, Silver Creek Elementary School will provide parents of participating children opportunities for regular meetings to formulate suggestions and to

- Through pre-arranged meetings with the Title I Coordinator
- Through meetings with the student's teacher which may include the Title I Coordinator, the principal, and other staff as appropriates.
- (b) Silver Creek Elementary School will submit to the district any parent comments if the school wide plan under section (1114)(b)(2) is not satisfactory to parents of participating children:
 - Parents may submit comments in writing regarding the school wide plan to their child's teacher, the Title I Coordinator, the principal, or the appropriate department with Silver Creek School Corporation.

Responsibilities for High Student Academic Achievement

- Silver Creek Elementary School will build the schools' and parents' capacity for strong parental involvement in order to ensure effective involvement of parents and to support a partnership between the school, parents, and the community to improve student academic achievement through the following activities described below:

Compliance with Head Start:

SCSC provides speech/language/hearing screenings for Sellersburg Head Start students annually and oversees the referral and evaluation process for Head Start students suspected of having disabilities. Once identified, eligible Head Start students who live within SCSC boundaries may receive speech therapy at the Head Start center during the preschool day and/or consult services as needed. Students who are found eligible for SCSC Developmental Preschool and for Head Start may be dually enrolled in both programs. Additionally, SCSC provides information on kindergarten roundup to Head Start families via flyers and announcements at the Sellersburg Center. Finally, SLPs have volunteered as guest readers in the Head Start classrooms, and the Preschool Coordinator has attended and participated in Head Start's annual self-assessment events.
