SCHOOL BOARD MEETING
SUMMARY
May 9, 2023

President Barry England called a meeting of the Williamsburg Community School Board to order at 7:07 p.m. Members present were: *Dr. Barry England, Patricia Kensinger, Benjamin Postles, Louis Brenneman, Adam Hileman, Jill Norris, Jimmy Grager, Carlee Ranalli, and Austin McMonagle*

Approval was received for the April 2023 minutes for the Committee of the Whole Meeting and Regular Board Meeting.



ITEMS BY THE BOARD:

*Elected Patricia Kensinger as School Board Treasurer for a one (1) year term and that a \$10,000 Surety Bond be furnished. Patricia donated the \$700 stipend back to the district.

*Appointed the following depositories for the 2023-24 school year:

*Approved letters of reasonable assurance of employment, as recommended by BUCS, our unemployment insurance carrier, be sent to employees based on their individual situations.

*Approved the Athletic Budget for the 2023-24 school year in the amount of \$41,740 with the Board contribution being \$15,929.

*Approved the Blair County Schools Health Consortium Medical and Prescription rates for 2023-24, reflecting a 3% increase

*Approved the Proposed Final Budget for the 2023-24 school year, reflecting a .4 millage increase, to be advertised pursuant with public advertising of availability for inspection for the required 30-day period.

*Approved the agreement with In-Shore to provide district technology services for a term of two (2) years beginning July 1, 2023 through June 30, 2025, at a cost of \$64,000 in year one and \$64,500 in year two.

* Accepted the Confidential Employee Compensation Plan beginning July 1, 2023 through June 30, 2026, reflecting a 3% pay increases for the term of the agreement, as presented.

*Approved the GACTC Budget for the 2023-24 school year in the amount of \$11,108,586.

*Authorized the Superintendent to submit the Federal and State funds applications for the 2022-23 school year, when completed.

*Agreed to provide a \$500 scholarship to the Valedictorian and Salutatorian of the class of 2023 by the Williamsburg Community School District Board of Directors.

*Approved Lisa Murgas, Superintendent, to appoint ESY and Summer School Teacher(s), at a stipend of \$25.00/hr.

*Approved the officials, game workers rates and ticket price rates for the 2023-24 school year, as presented.

* Appointed Jeff Detwiler as Varsity Boys' Basketball Head Coach, for the 2023-24 school year, at a stipend of \$4,727.

* Ratified the superintendent's approval of Grace Risbon's leave without pay request on May 4, 2023.

*Approved the following use of facilities request:

- a) Larry Burger and Dave Baney requesting use of the High School on August 25, 2023 for a Class of 73 and Class of 83 for a school tour.
- b) Dave Sollenberger is requesting the use of the football field on Saturday, July 22nd and Sunday, July 23rd for a 125th Anniversary celebration.
- c) Joe Detwiler and Jeff Detwiler are requesting the use of the old gym from 6/1/23 - 8/15/23, when available, for the 5th & 6th grade boys basketball team.
- d) Maggie Merritts is requesting the use of the auditorium for a spring practice camp for the Williamsburg marching band front on the days May 15, 16, 18, 19.
