SCHOOL BOARD MEETING
SUMMARY
May 11, 2021

President Barry England called a meeting of the Williamsburg Community School Board to order at 7:53 p.m. Members present were: *Barry England, Timothy Strohmeier, Julie Woodling Patricia Kensinger, Benjamin Postles and Janet Lee.*

Approval was received for the April minutes for the Committee of the Whole Meeting and Regular Board Meeting.



ITEMS APPROVED BY THE BOARD:

*Elected Patricia Kensinger as School Board Treasurer for a one (1) year term and that a \$10,000 Surety Bond be furnished. Patricia waived the \$700 stipend.

*Reappointed Clearfield Bank & Trust and First National Bank as depositories for the 2021-22 school year.

*Approved letters of reasonable assurance of employment, as recommended by BUCS, our unemployment insurance carrier, be sent to employees based on their individual situations.

*Approved the Athletic Budget for the 2021-22 school year in the amount of \$67,480 with the Board contribution being \$34,880.

*Approved the GACTC Budget for the 2021-22 school year in the amount of \$11,162,952.

*Approved the Proposed Final Budget for the 2021-22 school year, reflecting no millage increase, to be advertised pursuant with public advertising of availability for inspection for the required 30-day period.

*Approved the Blair County Schools Health Consortium Medical and Prescription rates for 2021-22, reflecting a 3% increase.

*Approved the 2021-22 Cafeteria budget with The Nutrition Group, as presented.

*Approved school lunch prices for the 2021-22 school year as follows:

Adult	\$3.10
Paid Breakfast	\$1.35

*Approved the purchase of a mobile classroom from Vanguard Modular. Purchase of mobile classroom will be made using ESSER II Grant Funds.

*Authorized the Superintendent to submit the Federal and State funds applications for the 2021-22 school year, when completed.

*Agreed to provide a \$500 scholarship to the Valedictorian and Salutatorian of the class of 2021 by the Williamsburg Community School District Board of Directors.

*Approved Lisa Murgas, Superintendent, to appoint ESY and Summer School Teacher(s), at a stipend of \$25.00/hr.

*Appointed Zachary Slagenweit as Remediation Teacher, at a salary of Bachelors Step 2 of the negotiated contract, for the 2021-22 and 2022-23 school years, to be paid using ESSER III funding.

*Appointed Chanelle Meadows as K-12 Art teacher beginning the 2021-22 school year at a salary of Bachelors Step 4, of the negotiated contract.

*The following Field Trip was approved:

5/14/2021 Horton/ 31 third grade students to Pleasant View Farm and Martinsburg
Brown Memorial Park, at no cost to the district.

*Approved the officials, game workers rates and ticket price rates for the 2021-22 school year, as presented.

* Approved the creation of a Jr. High Cross-Country Team as a zero funded sport with no district contribution.

*Accepted the resignation of Ben Mercer as Jr. High Head Football Coach, with regret.

*Approved the following use of facilities request:

a) Brock Anders is requesting use of the gym for Blue Pirates Camp on June 21-24, 2021 from 8:30 -12:00 each day.
