Approval was received for the April minutes for the Committee of the Whole Meeting and Regular Board Meeting.



ITEMS APPROVED BY THE BOARD:

*Heard a report from Mrs. Metzler and Ms. Edminson on the Elementary Student Assistance Program (SAP).

*Elected Patricia Kensinger as School Board Treasurer for a one (1) year term.

*Reappointed Clearfield Bank & Trust and First National Bank as depositories for the 2017-18 school year.

*Approved letters of reasonable assurance of employment, as recommended by BUCS, our unemployment insurance carrier, be sent to employees based on their individual situations.

*Approved the Athletic Budget for the 2017-18 school year in the amount of \$64,572 with the Board contribution being \$20,625.

*Approved the GACTC Budget for the 2017-18 school year in the amount of \$9,008,552.

*Approved the Proposed Final Budget for the 2017-18 school year to be advertised pursuant with public advertising of availability for inspection for the required 30-day period.
