	<p style="text-align: center;"><b>140. EXTRACURRICULAR PARTICIPATION BY CHARTER/CYBER CHARTER STUDENTS</b></p> <p><b>1. Purpose</b></p> <p>The Board recognizes the importance of providing requirements for charter/cyber students participating in the district's extracurricular programs. This policy has been developed to provide regulations, conditions, and procedures for charter/cyber school students when participating in an extracurricular activity in the District.</p> <p><b>2. Authority</b> SC 1719-A, 1743-A 1749-A Pol. 122, 123, 140</p> <p>The Board shall approve participation in the district's extracurricular activities and interscholastic athletic programs by a student enrolled in a charter or cyber charter school who meet all the conditions stated in Board Policy and the charter or cyber charter school does not provide the same extracurricular activity or interscholastic athletic program.</p> <p>The Board shall not provide individual transportation for students enrolled in charter or cyber charter schools who participate in the district's extracurricular activities or interscholastic athletic programs. When the district provides transportation to and from an away competition, game, event, or exhibition and requires district students to use district transportation, charter/cyber charter students shall be required to use the transportation provided by the district.</p> <p>The Board may require the charter or cyber charter school to pay the cost of the expenses for its students' participation in the district's extracurricular activities or interscholastic athletic programs.</p> <p><b>2. Guidelines</b></p> <p>Charter and cyber charter school students shall be given an equal opportunity to compete for positions and participate in extracurricular activities and interscholastic athletic programs.</p> <p>A charter or cyber charter school student may only participate in extracurricular activities and interscholastic athletic programs at the school building the student would be assigned to if s/he was enrolled in the District.</p>

<p>Pol. 122, 123 Pol. 123 Pol. 122, 123, 218 SC 511 Pol. 204 Pol. 123</p>	<p>The following guidelines shall govern participation in the district's extracurricular activities and interscholastic athletic programs by eligible charter and cyber charter school students, who shall:</p> <ol style="list-style-type: none"> <li>1. Be a resident of the school district.</li> <li>2. Meet the required eligibility criteria.</li> <li>3. Maintain appropriate insurance coverage, consistent with the coverage requirements for the district students.</li> <li>4. Comply with Board policies and school rules and regulations regarding extracurricular activities, interscholastic athletics, and student discipline.</li> <li>5. Comply with policies, rules and regulations of the activity's governing organizations.</li> <li>6. Meet attendance and reporting requirements established for all participants of the activity or program.</li> <li>7. Meet the requirements for physical examinations, physical fitness and any height and/or weight restrictions.</li> <li>8. Comply with all requirements and directives of the district staff, coaches, and administrators involved with the extracurricular activity or interscholastic athletic program.</li> </ol>
<p>3. Delegation of Responsibility</p>	<p>The building principal or designee shall ensure that charter and cyber charter students have access to information regarding the district's extracurricular activities and interscholastic athletic programs.</p> <p>The building principal or designee shall receive and review written verification from the charter or cyber school that a student has met and continues to meet the established eligibility criteria for an extracurricular activity or interscholastic athletic program.</p> <p>The building principal or designee shall distribute information regarding eligibility criteria and student participation in extracurricular activities and interscholastic athletics to all affected by them.</p> <p>References: Charter Schools – 24 P.S.
