2. Purpose of the committee – WHY?

a. Required by law in the State of Texas – Senate Bill 11; Education Code Chapter 37

b. The committee shall:

- i. participate on behalf of the district in developing and implementing emergency plans consistent with the district multi-hazard emergency operations plan required by Section 37.108(a) to ensure that the plans reflect specific campus, facility, or support services needs;
- ii. periodically provide recommendations to the district's board of trustees and district administrators regarding updating the district multi-hazard emergency operations plan required by Section 37.108(a) in accordance with best practices identified by the agency, the Texas School Safety Center, or a person included in the registry established by the Texas School Safety Center under Section 37.2091;
- iii. provide the district with any campus, facility, or support services information required in connection with a safety and security audit required by Section 37.108(b), a safety and security audit report required by Section 37.108(c), or another report required to be submitted by the district to the Texas School Safety Center;
- iv. review each report required to be submitted by the district to the Texas School Safety Center to ensure that the report contains accurate and complete information regarding each campus, facility, or support service in accordance with criteria established by the center; and
- v. consult with local law enforcement agencies on methods to increase law enforcement presence near district campuses.

3. Confidentiality is paramount

a. A district's multi-hazard emergency operations plan is not public.

b. An interested person may request access to a document that verifies that the district has established an emergency operations plan.

 - ii. Approve revisions (if any) for Wommack to make to EOP
 - iii. Send to board for approval after review
 - c. Update campus emergency operations plan
 - i. Each campus will have a plan specific to their campus
 - ii. Member of this committee will be in charge of that plan
 - d. Reporting Mechanism – STOPit
 - e. Stop the Bleed
 - f. Organization of District Threat Assessment Committee
 - g. Safety Audit
