John Clancy-Joseph Maggiore Elementary School for the Arts Parent and Family Engagement Policy

PART I GENERAL EXPECTATIONS

John Clancy-Joseph Maggiore Elementary School for the Arts agrees to implement the following statutory requirements:

John Clancy-Joseph Maggiore Elementary School for the Arts will take the following actions to provide each parent timely notice when their child has been assigned or has been taught for four (4) or more consecutive weeks by a teacher who is not highly qualified within the meaning of the term in section 200.56 of the Title I Final Regulations (67 Fed. Reg. 71710, December 2, 2002) by:

8. John Clancy-Joseph Maggiore Elementary School for the Arts provide assistance to parents of children served by the school, as appropriate, in understanding topics by undertaking the actions described in this paragraph -
