PART I. GENERAL EXPECTATIONS OF THE PARENT INVOLVEMENT POLICY

Dove Science Academy South ES OKC agree to implement the following statutory requirements:

- *The school will put into operation programs, activities and procedures for the involvement of parents with Title I, Part A programs. Those programs, activities and procedures will be planned and operated with meaningful consultation with parents of participating children.*

(E) parents are involved in planning, development, and implementation in effective school activities to focus on improving student academic achievement;

(F) that improving school performance by helping the families learn how and when to assist their children in classroom learning activities techniques, strategies, and skills to use at home

1. Dove Science Academy South ES OKC will take the following actions to involve parents in the joint development of its school wide parental involvement plan:

4. Dove Science Academy South ES OKC will coordinate and integrate parental involvement strategies in Part A with parental involvement strategies under the following other programs:

o PTO Meetings, Parent Information Nights, Science Fair, Book Fair, Muffins for Moms, Donuts for Dads, Talent Shows, Language Competitions, End of year Celebrations, Parent Picnic, Kids on the block, Spelling Bee, Character of the Month, Student of the Month, Dove Store, Clubs Fair, Career Fair, Fall festival, Spring Festival, Parent Academy, Curriculum Nights.

5. Dove Science Academy South ES OKC will take the following actions to conduct, with the involvement of parents, an annual evaluation of the content and effectiveness of this parental involvement policy in improving the quality of the school. The evaluation will include identifying barriers to greater participation by parents in parental involvement activities (with particular attention to parents who are economically disadvantaged, are disabled, have limited English proficiency, have limited literacy, or are of any racial or ethnic minority background). - o Information on standards and assessments are shared at parent teacher conferences.

The school will, with the assistance of teachers, provide materials and training to help parents work with their children to improve their children's academic achievement, such as literacy training, and using technology, as appropriate, to foster parental involvement, by:

- o Hosting a Back to School Night and Open House.
- o Offering parents e-mail addresses to all professional staff.
- o Offering parents a home visit during the school year.
- o Offering all parents a secured internet based grade reporting system.
- o Offering information to all parents through the school website.
- o Providing all students with a student handbook.

The school will, with the assistance of parents, educate its teachers, pupil services personnel, principals and other staff, in how to reach out to, communicate with, and work with parents as equal partners, in the value and utility of contributions of parents, and in how to implement and coordinate parent programs and build ties between parents and school, by:

- o Administrative team meetings
- o Title I staff meetings
- o Parent Teacher Organization meetings

The school will take the following actions to ensure that information related to the school and parent- programs, meetings, and other activities, is sent to the parents of participating children in an understandable and uniform format, including alternative formats upon request, and, to the extent practicable, in a language the parents can understand:
