News Release: 2016 State Accountability Ratings

For Immediate Release

(August 15, 2016) – Crowley ISD continues to exceed state standards in all four of the key academic indexes in the State of Texas Assessments of Academic Readiness (STAAR), with more campuses achieving success in student progress, closing performance gaps and postsecondary readiness.

Results released today by the Texas Education Agency (TEA) show the district and 17 of its 19 tested campuses have been rated at the top level of "Met Standard" for 2016. (TEA news release)

The TEA has delayed the release of the academic "Distinction Designations." Many Crowley ISD campuses are expected to receive numerous distinctions. These distinctions are scheduled to be released in September.

District Summary:

- ✓ Index 1 (Student Achievement) Crowley ISD "Met Standard"
- ✓ Index 2 (Student Progress) Crowley ISD "Met Standard"
- ✓ Index 3 (Closing Performance Gaps) Crowley ISD "Met Standard"
- ✓ Index 4 (Postsecondary Readiness) Crowley ISD "Met Standard"

Campus Summary:

- 89% of tested campuses in Crowley ISD "Met Standard" by meeting all applicable state index targets. (5-point increase from 2015)
- Two campuses were rated "Improvement Required" in 2016, compared to three campuses in 2015.
- All of the campuses that were rated "Improvement Required" in 2015 improved to "Met Standard" in 2016.
- 88% of the required campus performance indexes (67 of 76) were met or exceeded by Crowley ISD students. (1-point increase from 2015)
 - Index 1 (Student Achievement) 68% of Crowley ISD's campuses (13 of 19) exceeded state standards. (18-point decrease from 2015)
 - Index 2 (Student Progress) 89% of Crowley ISD's campuses (17 of 19) exceeded state standards. (15-point increase from 2015)
 - Index 3 (Closing Performance Gaps) 95% of Crowley ISD's campuses (18 of 19) exceeded state standards. (6-point increase from 2015)
 - Index 4 (Postsecondary Readiness) 100% of Crowley ISD's campuses (19 of 19) exceeded state standards. (unchanged from 2015)

To receive a "Met Standard" rating, districts and campuses must meet the performance index target on either Index 1 or Index 2 as well as the targets on Index 3 and Index 4.

Among Crowley ISD's campuses, both high schools were rated as "Met Standard," all three middle schools were rated as "Met Standard," all four intermediate schools were rated as "Met Standard" while eight out of 10 elementary schools were rated as "Met Standard." 2016 ratings apply one of two labels to districts and campuses: "Met Standard" or "Improvement Required" based on performance in four key academic indexes. The TEA has produced a short online video that explains the accountability system. Click here to watch.

"State tests are just one of the many tools we use in Crowley ISD as we strive to provide our students with excellence in education," Superintendent Dan Powell said. "These latest results show significant academic gains and highlight specific needs in our schools that will help us identify key areas of intervention and enrichment as we help all students achieve their full potential."

"But, we will not let ratings from a complicated and controversial state accountability system dictate how we teach students," Dr. Powell said. "Our educators are committed to increasing levels of student achievement in every classroom across our district regardless of the unpredictable labels assigned to our schools in this constantly changing accountability system."
