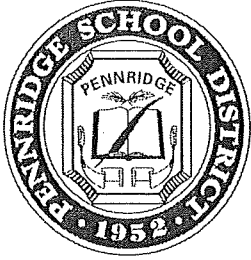

Dear Pennridge Taxpayer,

On Behalf of the Pennridge School Board, we are pleased to announce we will continue to offer the Senior Tax Rebate Program which began in July 2020.

For program year 2024/2025, qualifying applicants would be eligible to receive an additional rebate on their property taxes of 25% of the amount of tax relief provided by the PA state property tax rebate program. The table below shows the maximum rebate for eligible applicants:

Pennsylvania Tax Rebate Program		Pennridge SD Tax Rebate Program
Income Level	Max Standard Rebate	25% of PA Max Standard Rebate
\$0 to \$8,000	\$1,000	\$250.00
\$8,001 to \$15,000	\$770	\$192.50
\$15,001 to \$18,000	\$460	\$115.00
\$18,001 to \$45,000	\$380	\$95.00

To qualify for the Pennridge rebate, applicants must meet the following requirements:

- Homeowner with a household income of not more than \$45,000 annually **AND**
- 65 years of age or older; or be a widow / widower aged 50 years old or older; or be permanently disabled and 18 years of age or older.
- Qualify for the Pennsylvania Property Tax Rebate.

Eligible applicants for the Pennridge District Tax Rebate Program **MUST** submit a completed copy of the Pennridge School District Property Tax Rebate form (found on the reverse side of this letter), a completed copy of pages one and two of the PA Form 1000 for year 2023 and proof of the 2023 rebate payment from PA Department of Revenue to the school district office to receive an additional rebate from the district for 25% of the value issued at the state level.
