October 12, 2021

The Stillwater Township Board of Education met on October 12, 2021 at 7:00 p.m. in the Stillwater School All Purpose Room for a Regular Board of Education Meeting.

The meeting was called to order by Dennis DeGroat at 7:00 p.m. In accordance with the New Jersey Open Public Meetings Law, the time, date and location of this meeting was provided to the New Jersey Herald, Township Journal & Star Ledger on January 5, 2021. Change of location was provided to the New Jersey Herald on September 30, 2021. Notices were posted in the Stillwater School, Town Hall, Stillwater Post Office, Middleville Post Office, Swartswood Post Office and the Stillwater School Website.

# **LEGISLATION**

- -One bill requires the state to provide a 10-cent per meal supplement to the existing federal reimbursement to operators of federal summer food service programs and the Seamless Summer Option. This law goes into effect on June 1, 2022.
- -Another bill requires the state to provide a 10-cent per breakfast supplement to the existing federal reimbursement to a school district with schools that participate in the federal school breakfast program by providing "breakfast after the bell." This law will take effect at the beginning of the 2022-2023 school year.
