The Stillwater Township Board of Education met on November 7, 2022 at 7:00 p.m. in the Stillwater School Library for a Committee of the Whole Board of Education Meeting.

The meeting was called to order by Krista Galante at 7:00 p.m. In accordance with the New Jersey Open Public Meetings Law, the time, date and location of this meeting was provided to the New Jersey Herald & Star Ledger on January 4, 2022. Notices were posted in the Stillwater School, Town Hall, Stillwater Post Office, Middleville Post Office, Swartswood Post Office and the Stillwater School Website.

<u>Cody Castner-</u> 929 Fairview Lake Road, Newton, NJ- questioned the feasibility study. Even if it is grant funded, it could be a waste of money if the community will not approve it. He also questioned if the feasibility study only lists the positives or if it lists the negatives to regionalization as well. Mr. Castner also questioned what the study would look at; will it look at security? He brought up the concerns from the Wallkill H.S. situation, and he would not like all the students under one roof.

Dr. Kochis responded that the feasibility study would list both the positive and negatives of the potential regionalization based off the examples of South Hunterdon Regional and Salem County studies. Dr. Kochis also stated that if we regionalize, the students would not be all under one roof. It would be similar to each town stays in their school, or potentially shifted schools by grade levels.

<u>Kaitlyn Hammerle-</u> 952 Millbrook Road, Newton, NJ 07860- Since the South Hunterdon study did not make sense financially, but did educationally, how do they look at the educational piece in the study? Our test scores that were reported out from a prior meeting looked good, so how would regionalizing improve them more? Also, stated she agrees with Mr. Franek that the State is going to take our money anyway. She also does not think regionalization will be accepted in the Stillwater community.
