## SUMMARY

Washes dishes, pots and pans required for the preparation of breakfasts, lunches and assists with occasional catering functions for students, staff, and patrons of the school district by performing the following duties.

**ESSENTIAL DUTIES AND RESPONSIBILITIES** include the following. Other duties may be assigned.

- Washes dishes, pots, pans and other kitchen equipment by hand or with dishwashing machines.
- Scrapes left-over food from dishes, places dishes in dishwashing machine, adds soap, and turns on machine.
- Removes clean dishes from machine and places them in serving areas.
- · Cleans kitchen areas including sweeping and mopping.
- Requisitions food and supplies through Director of Nutrition Services.
- Restocks items as needed.
- Serves individual portions of food to customers.
- Keeps serving lines supplied with napkins, silverware, dishes.
- Obeys safety rules as outlined in Opaa!'s "Safety Procedure Manual" and exercises caution in all work activities.
- Reports any unsafe working condition to the appropriate supervisor.
- Attends all required training meetings and in-services. Participates in the safety incentive program.

#### QUALIFICATIONS

To perform this job successfully, an individual must be able to perform each essential duty satisfactorily. The requirements listed below are representative of the knowledge, skill, and/or ability required. Reasonable accommodations may be made to enable individuals with disabilities to perform the essential functions.

#### **EDUCATION and/or EXPERIENCE**

Less than high school education; or up to one month related experience or training; or equivalent combination of education and experience.

#### LANGUAGE SKILLS
