Two property owners recently presented the district with an opportunity to purchase their properties located behind Roseburg High School.

Following consideration, the School Board gave their unanimous approval to move forward with offers to purchase the two homes including 364 West Selmar Court at a purchase price of \$300,000 as well as 642 West Finlay at a purchase price of \$499,000. There is now one remaining property between the high school and the river.
