Fort Edward CSD Letter to Parents for School Meal Programs Special Provision Options (Provision 2 Non-Base Year & Community Eligibility Provision)

Dear Parent or Guardian:

We are pleased to inform you that <u>Fort Edward CSD</u> will be implementing a meal certification option available to schools participating in the National School Lunch and School Breakfast Programs for <u>2024-2025 school year</u>.

What does this mean for your child(ren) attending the school(s) identified above?

All students enrolled at <u>all Fort Edward CSD schools</u> are eligible to receive a healthy breakfast and lunch at school at <u>no charge</u> to your household each day of the <u>2024-2025</u> school year. No further action is required of you. Your child(ren) will be able to participate in these meal programs without having to pay a fee or submit an application.
