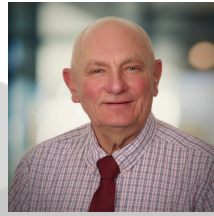

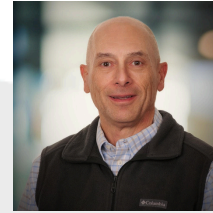

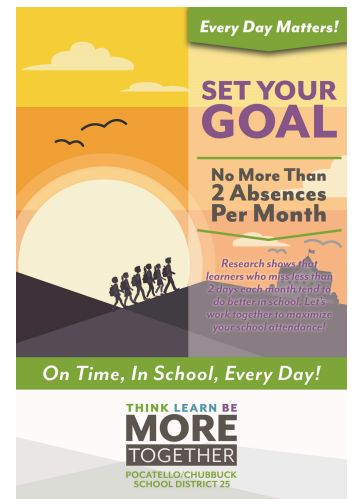
## On Time, In School, Every Day! Attendance Campaign
