The International Leadership of Texas (ILTexas) Child Nutrition Department understands that you may want to limit your student's daily spending in the cafeteria. This form is required only if a parent and/or guardian wishes to request restrictions on their student's meal account. All students use a personal identification number to purchase meals and/or a la carte items.

- ◆ Students can use cash or funds from their meal account to purchase meals, extra entrees, sides, and/or beverages.
- ◆ **Students are not permitted to charge any items other than a meal when there are insufficient funds in the account. In addition, students who do not have money are allowed to charge up to \$50.00 for a reimbursable meal.**
- ◆ If you would like to place spending limits or restrictions on your student's meal account, complete and return this form to your campus Cashier or e-mail this form to [childnutrition@iltexas.org](mailto:childnutrition@iltexas.org).
- ◆ Spending limits and/or restriction will not be removed until a written request is submitted by a parent or guardian.
