A few things to note...

- 1) With the exception of the unemployment rate, all data is PRE-COVID. The current reality is that every day, supply and demand for child care changes in response to, or as a result of, coronavirus. For the most up-to-date information about whether a particular center or family child care home is open, contact the Stanislaus County Child Care Resource & Referral program, at (209) 238-6400 or go to www.findchildcarestanislaus.org. An updated assessment will be published when there is more stabilization in the data.
- 2) It is recognized that child care is often provided by friends, family, and neighbors (FFN's). This type of informal child care arrangement is difficult to count, however there are approximately 130 FFN's that are known in Stanislaus County because of their participation in various early care and education trainings/workshops available to the community.
- 3) Funders drive data that is collected and available to conduct the needs assessment. Given the diversity of programs and funders, estimating supply and demand is more of an art than a science due to the misalignment, fragmentation, and duplication of the various available data sources. The Stanislaus Child Development Local Planning Council continues to work towards developing an assessment that is a true reflection of child care supply, demand, and unmet need in the county.

ABOUT THE STANISLAUS CHILD DEVELOPMENT LOCAL PLANNING COUNCIL

As a result of the passage of California Assembly Bill 1542, local county child care and development planning councils were established with the purpose of providing a forum that identifies the local priorities for child care and the development of policies to meet the needs identified within those priorities.

Sixteen members of each county Local Planning Council are selected by the county Board of Supervisors and the county Superintendent of Schools and represent specific categories as outlined in legislation. Those categories are:

- **Consumer** – Parent or person who receives, or who has received child care services within the past 36 months;
- **Child Care Provider** – Person who provides child care services or represents persons who provide child care services;
- **Public Agency** – Person who represents a city, county, city and county, or local education agency;
- **Community Representative** – Person who represents an agency or business that provides private funding for child care services, or who advocates for child care services through participation in civic or community-based organizations but is not a child care provider and does not represent an agency that contracts with the State Department of Education to provide child care and development services;
- **Discretionary** – Determined by the appointing bodies. The determination must fall within one of the four above-listed categories.

BACKGROUND

As part of the responsibilities of the Stanislaus Child Development Local Planning Council, outlined in California Education Code Section 8499.3 – 8499.7, an assessment of child care needs in Stanislaus County is to be conducted no less than once every five years.

This child care needs assessment includes, but is not limited to, the following factors.

Overall Child Care Needs

- Waiting lists for programs funded by the California Department of Education
- Number of children needing child care services by age group
- Supply, demand, cost, and market rates for each category of child care in the county

Migrant Children & Families

- Number of children in migrant agricultural families who move from place to place for work or who are currently dependent for their income on agricultural employment
- Unique needs based on geographic considerations, including rural areas

Economic Factors

- Needs of families eligible (and not eligible) for subsidized child care.
- Number of children in families receiving public assistance, including food stamps, housing support, Medi-Cal, and assistance from the Healthy Families program and the Temporary Assistance to Needy Families (TANF) program
- Family income among families with preschool or school age children

High Need / High Risk Children

- Need for child care for children determined by the child protective services agency to be (or at risk to be) neglected, abused, or exploited
- Number of children who have been determined by a regional center to require services pursuant to an individualized family service plan, or by a local educational agency to require services pursuant to an individualized education program or an individualized family service plan
- The number of children in the county by primary language spoken

Based upon the information collected, the Stanislaus Child Development Local Planning Council makes a determination of the child care needs in Stanislaus County for each age group below and develops local priorities for funding by zip code area.

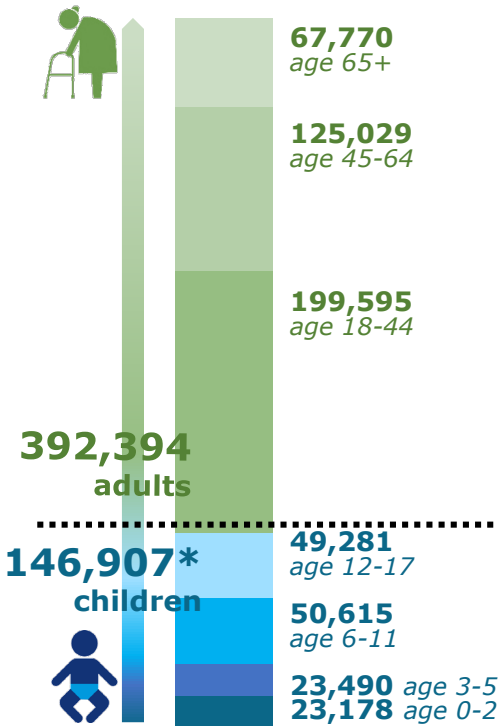

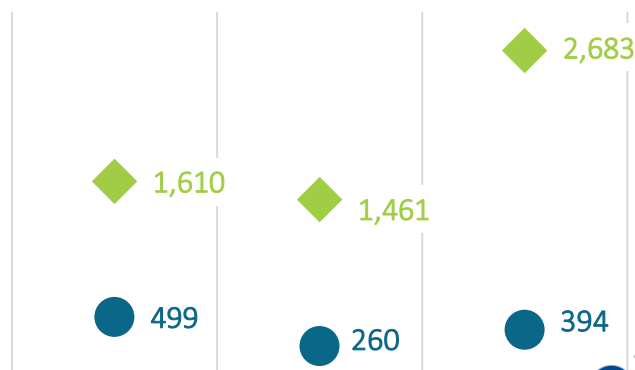

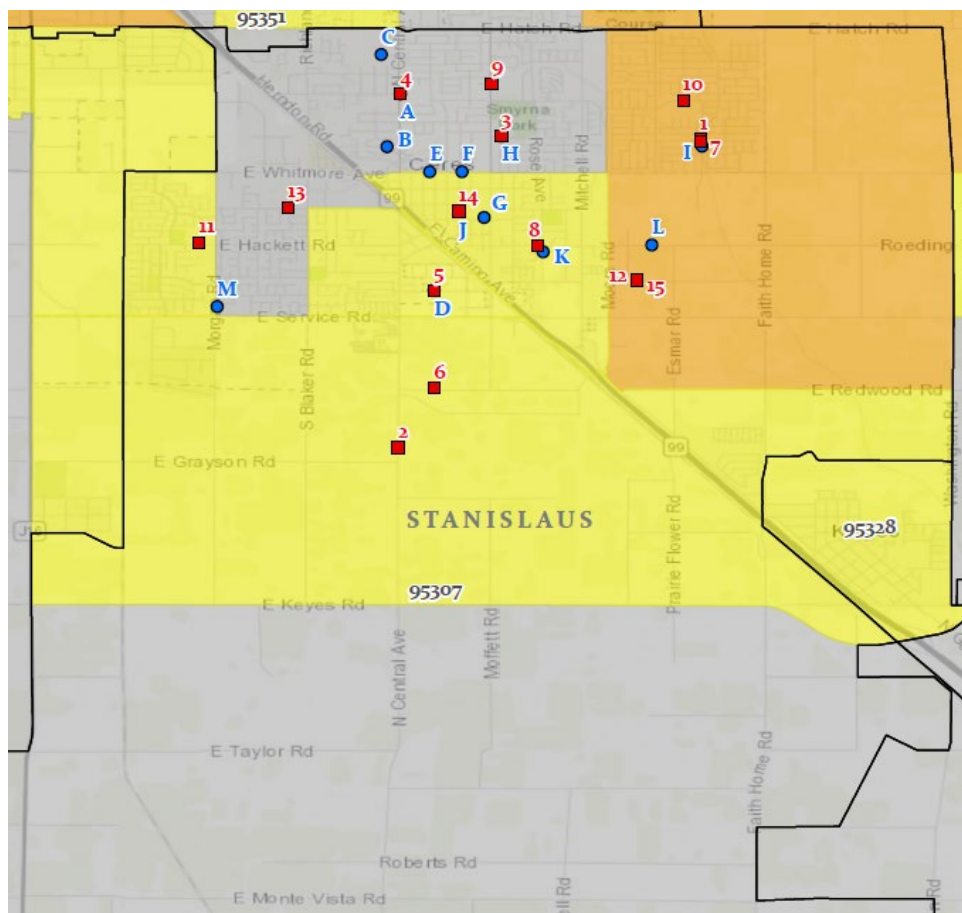

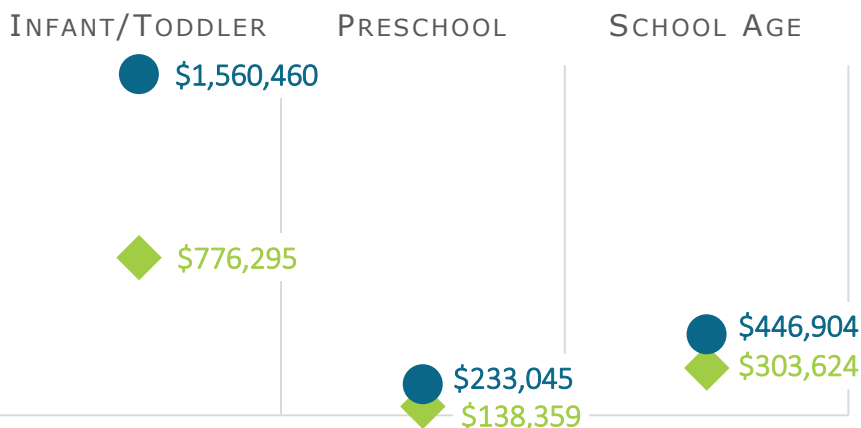

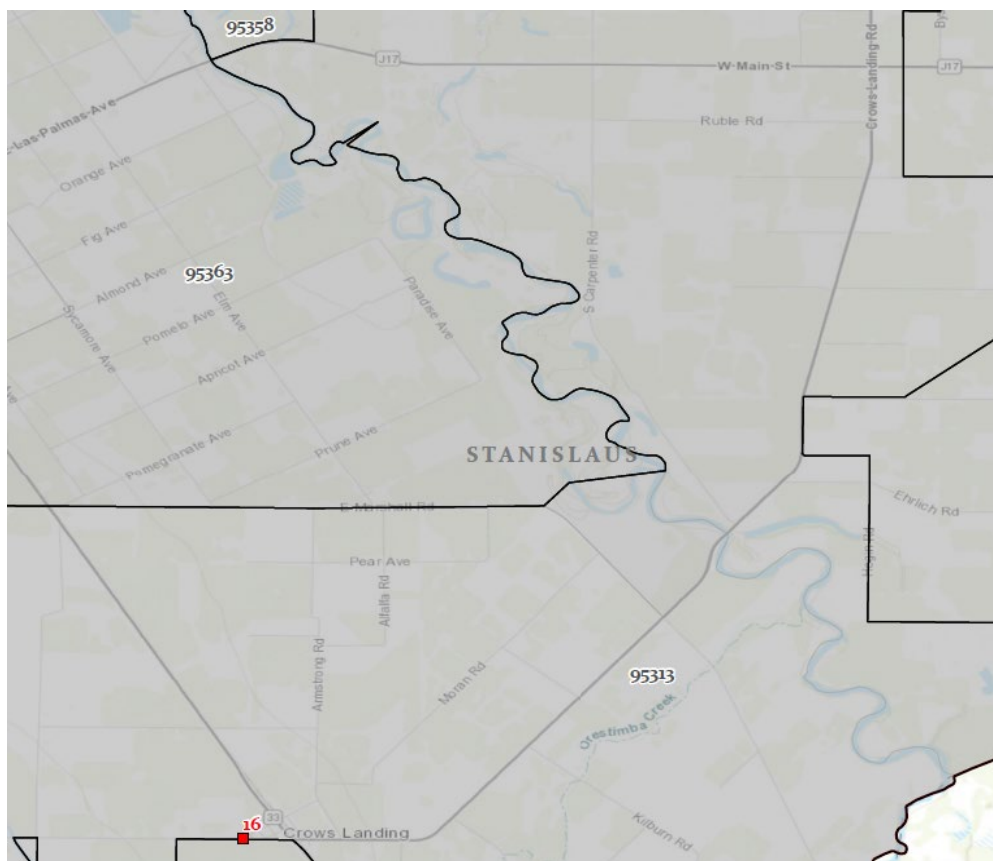

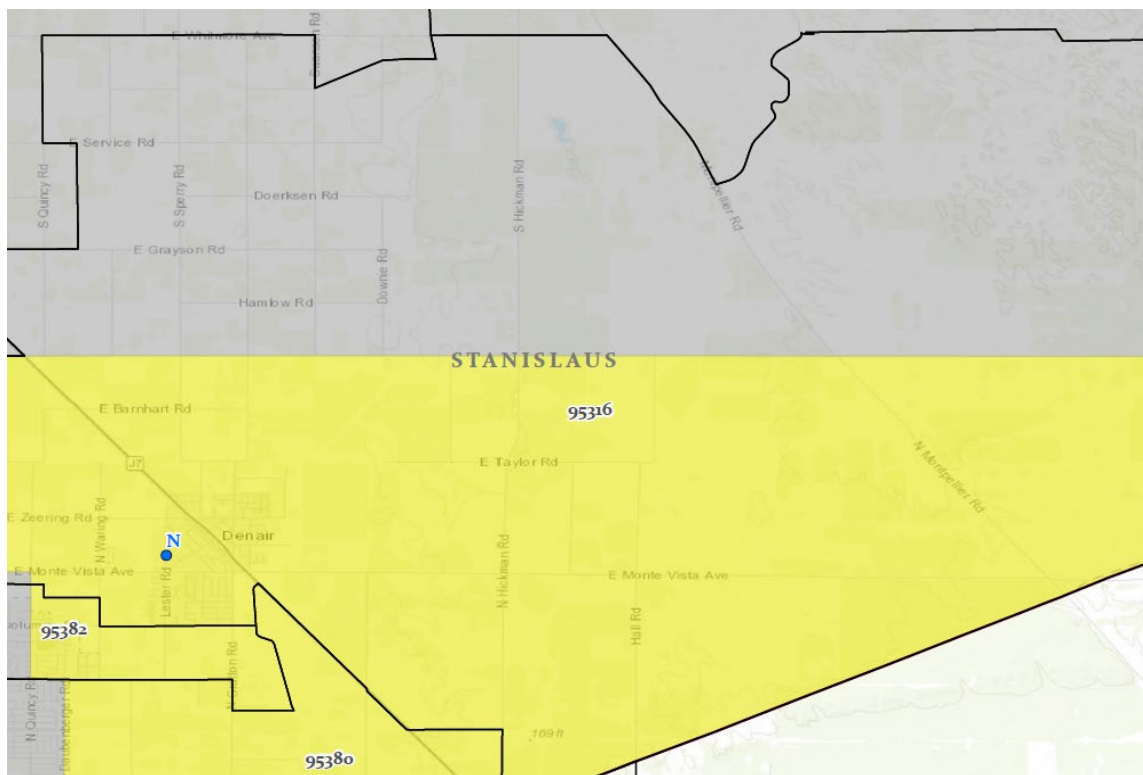

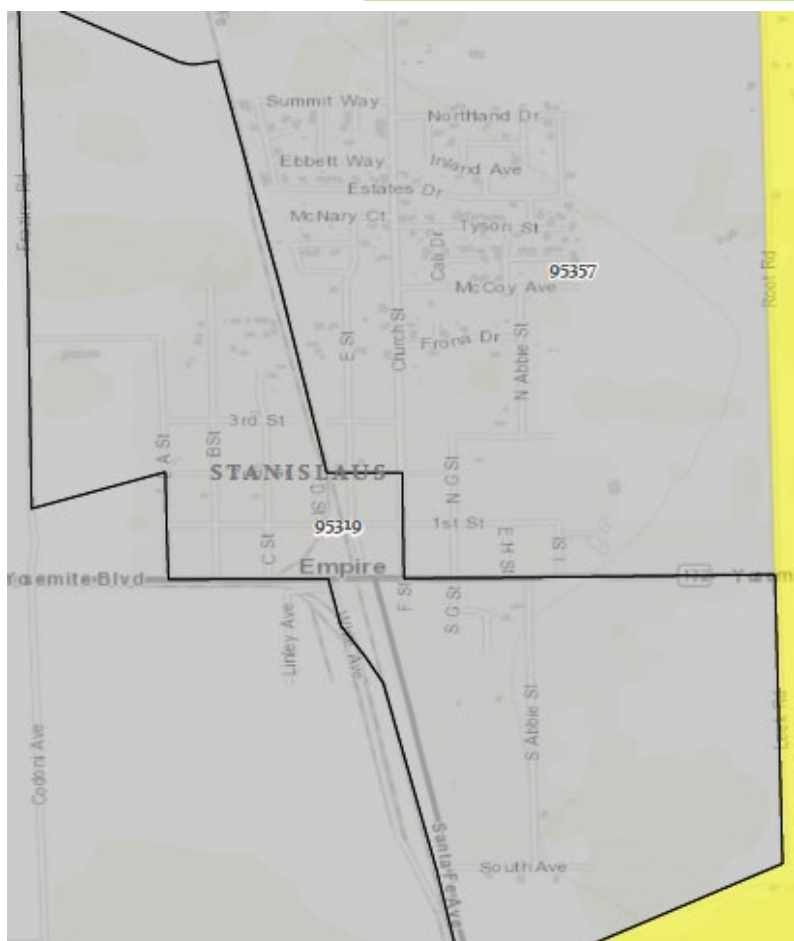

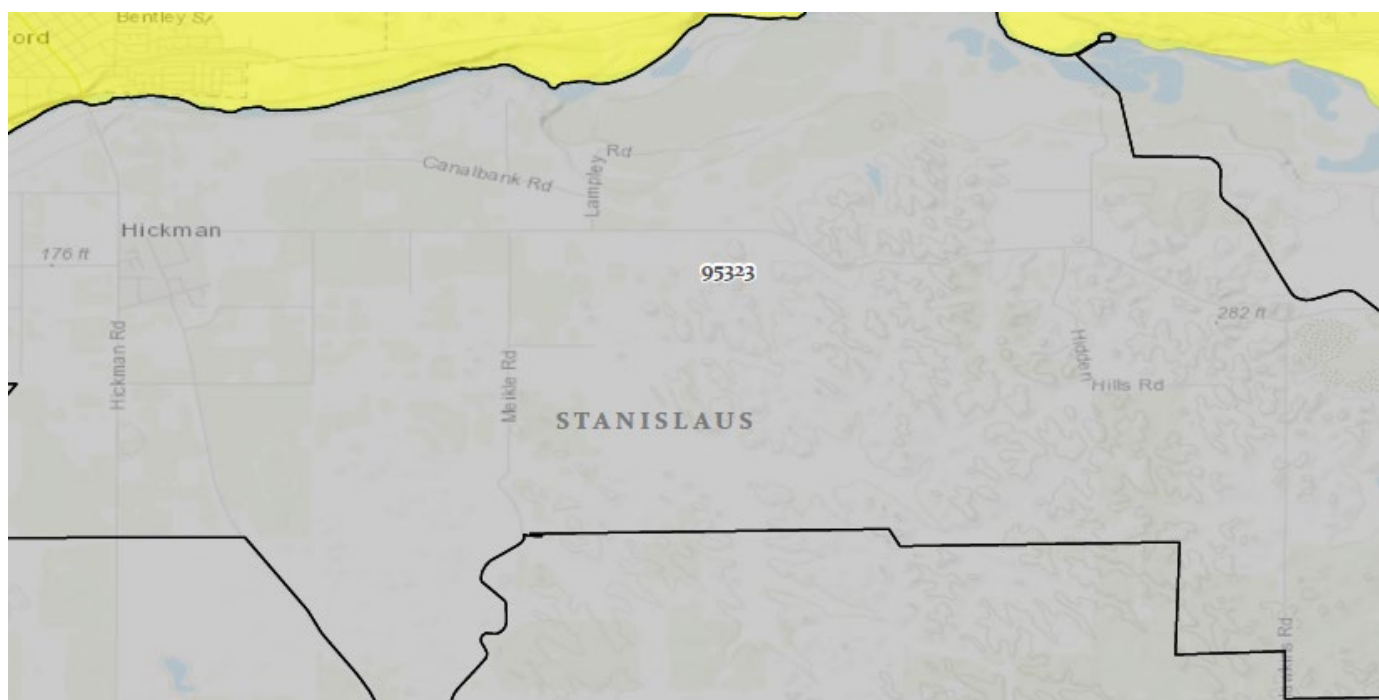

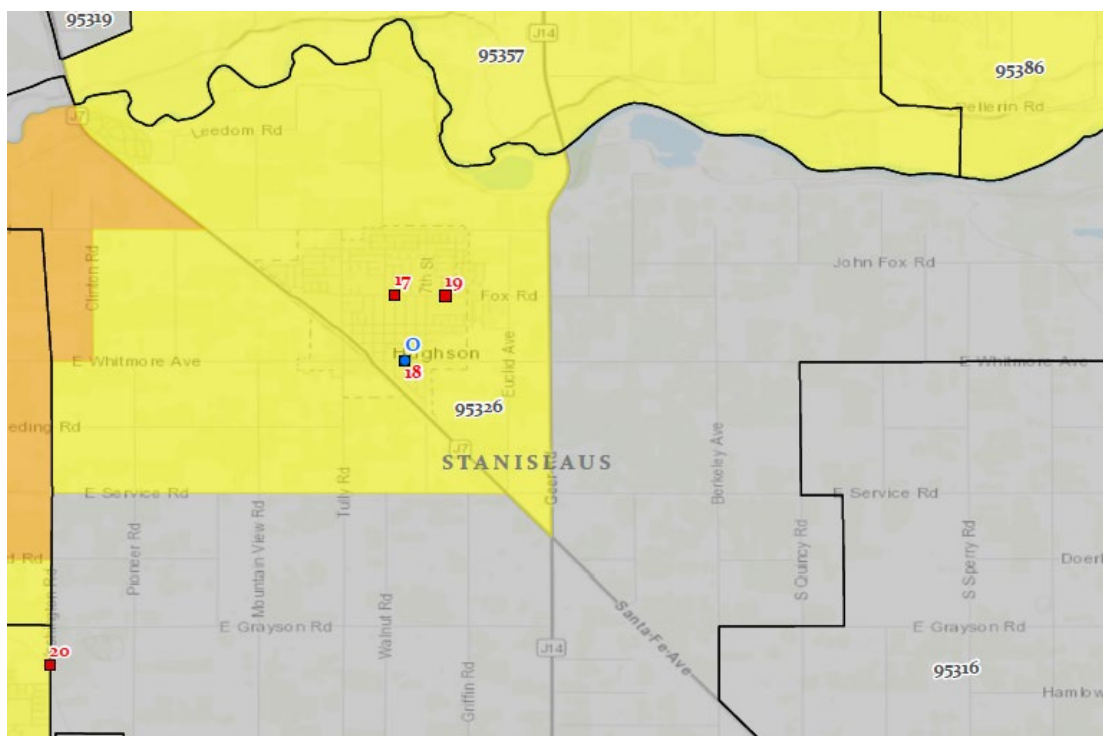

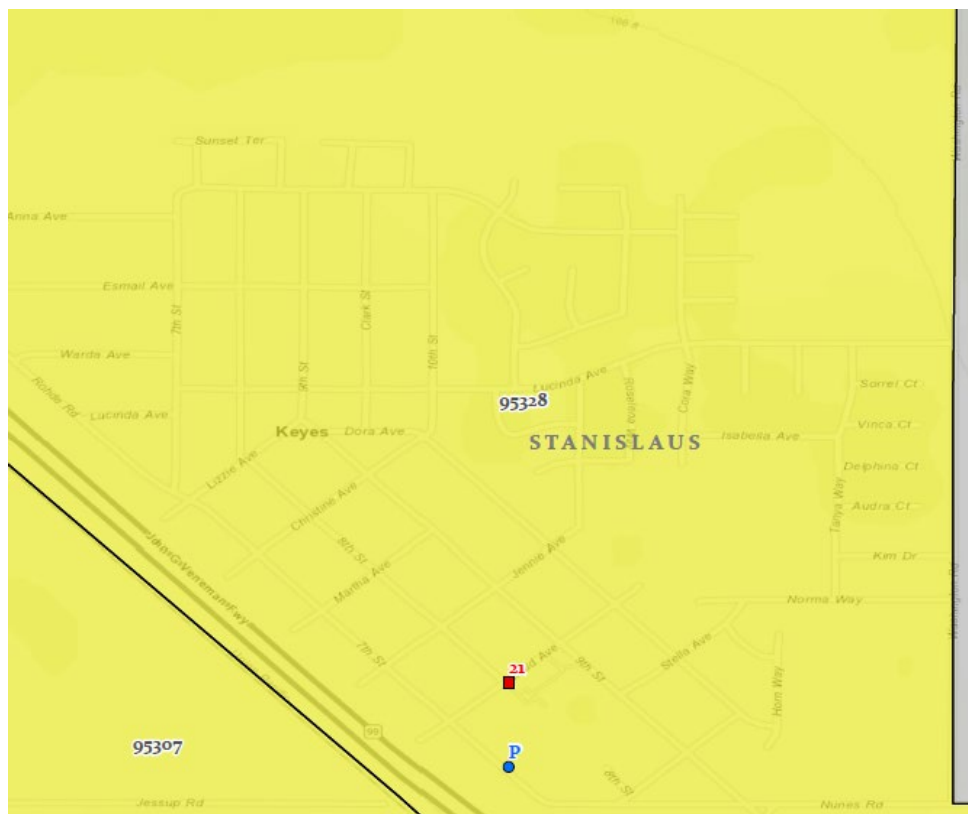

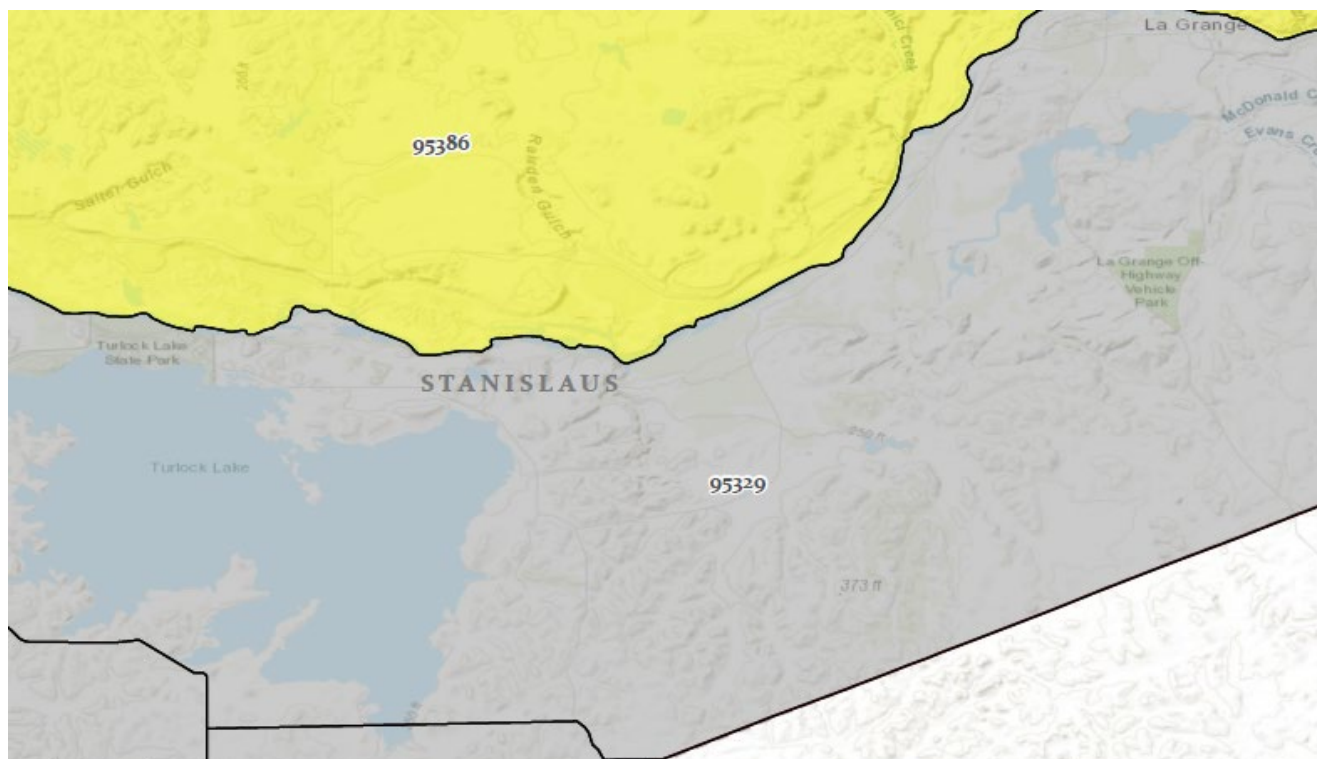

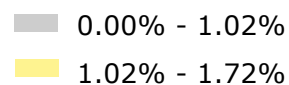

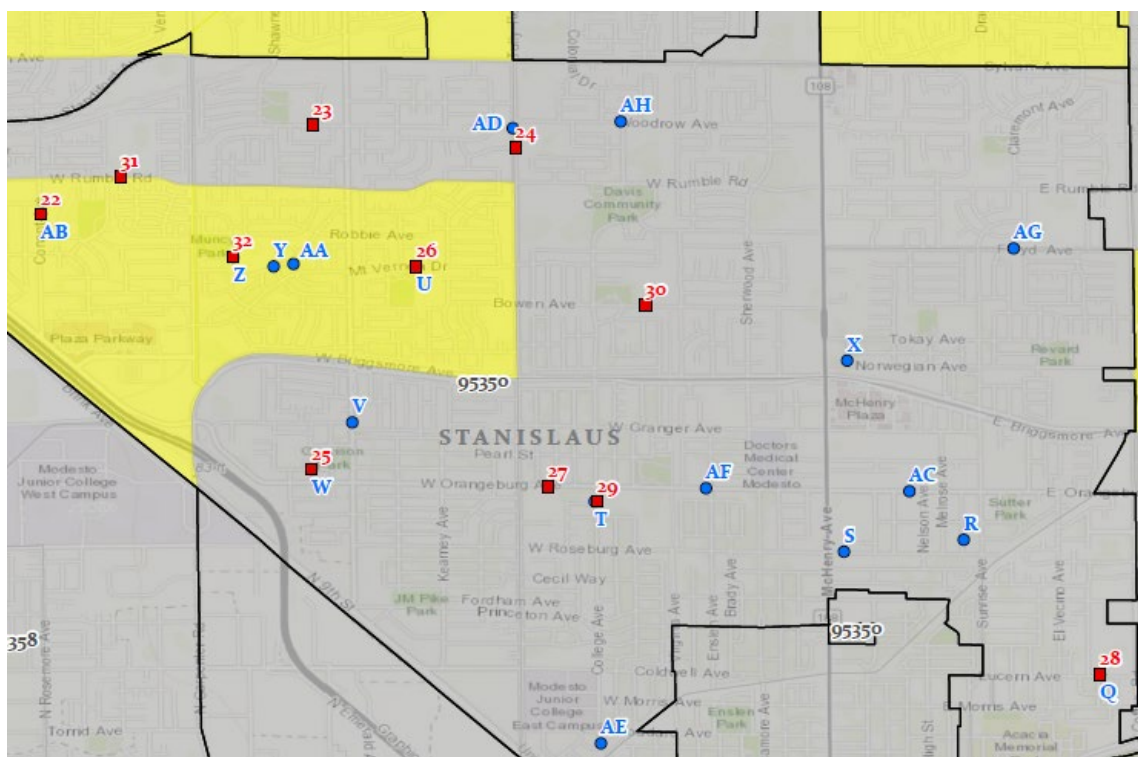

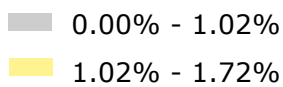

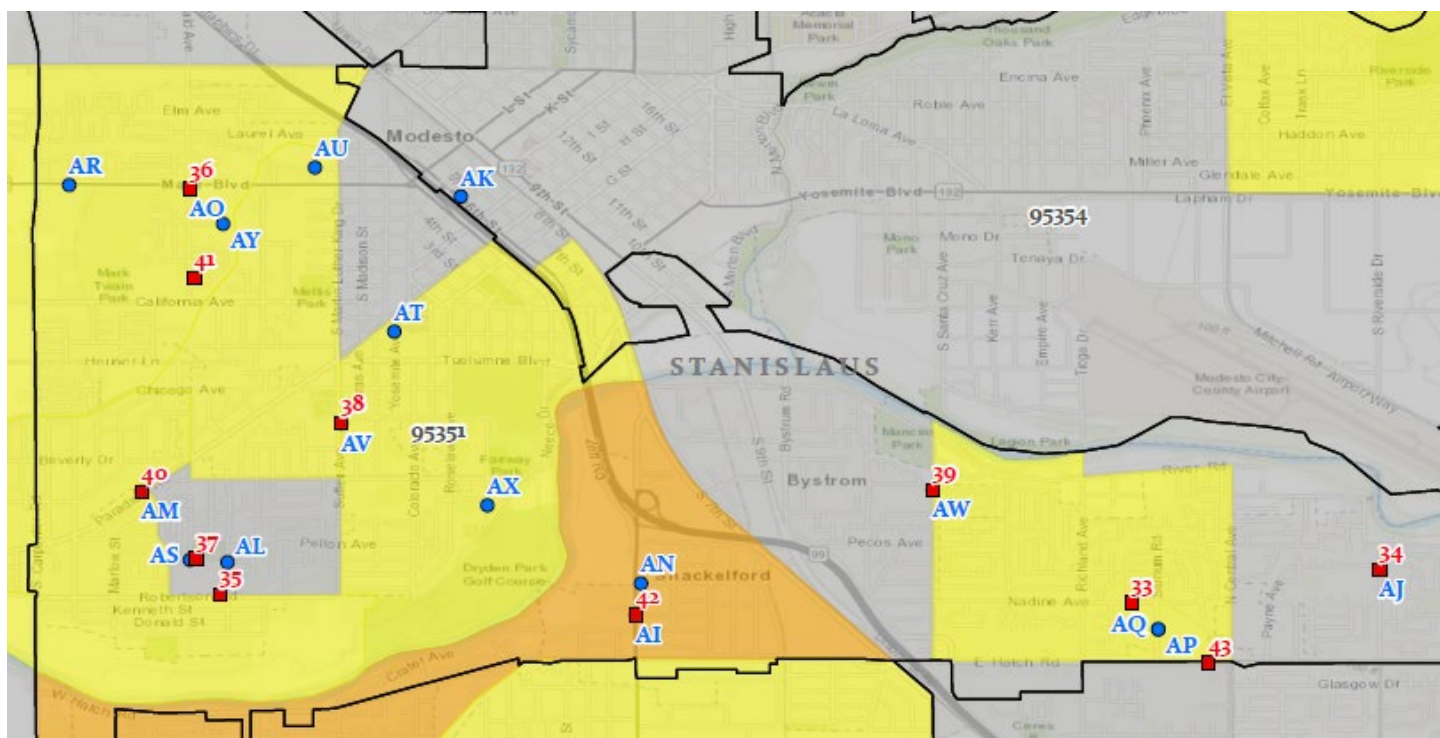

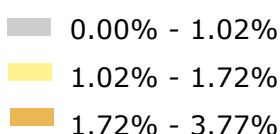

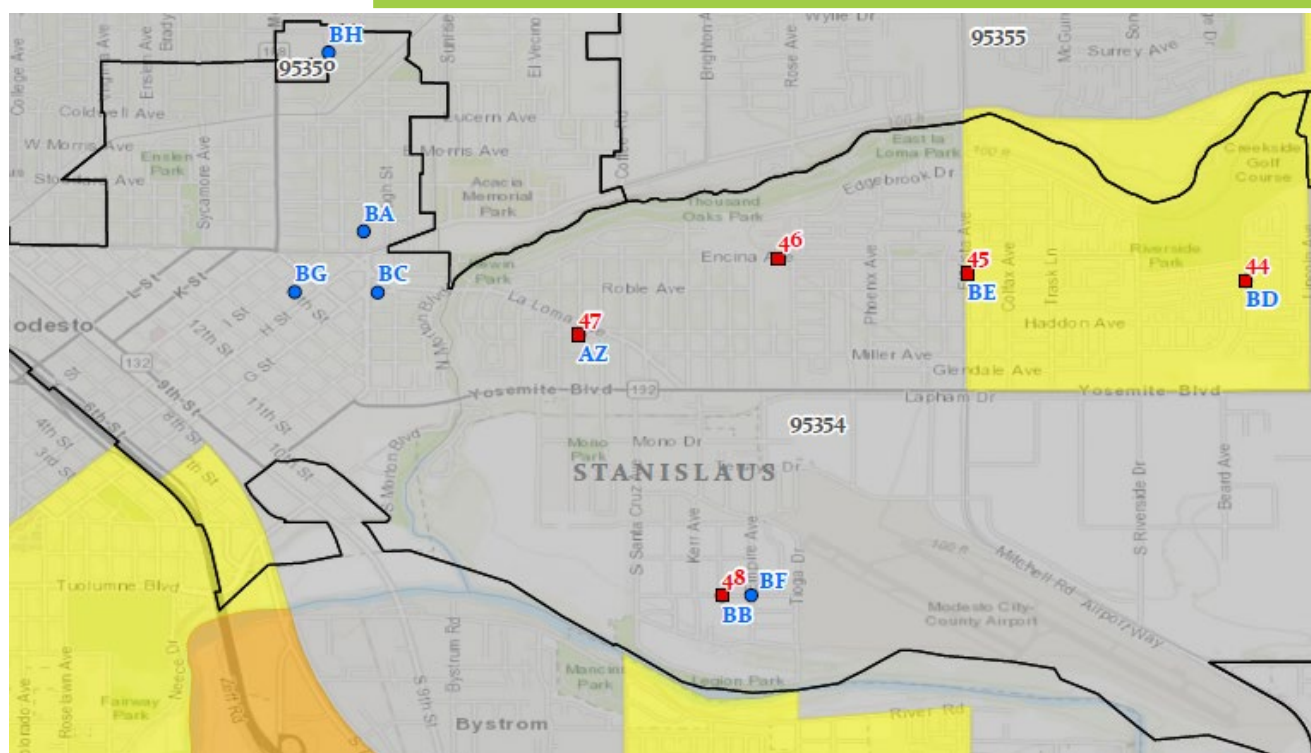

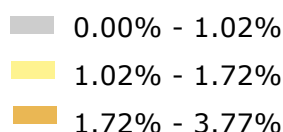

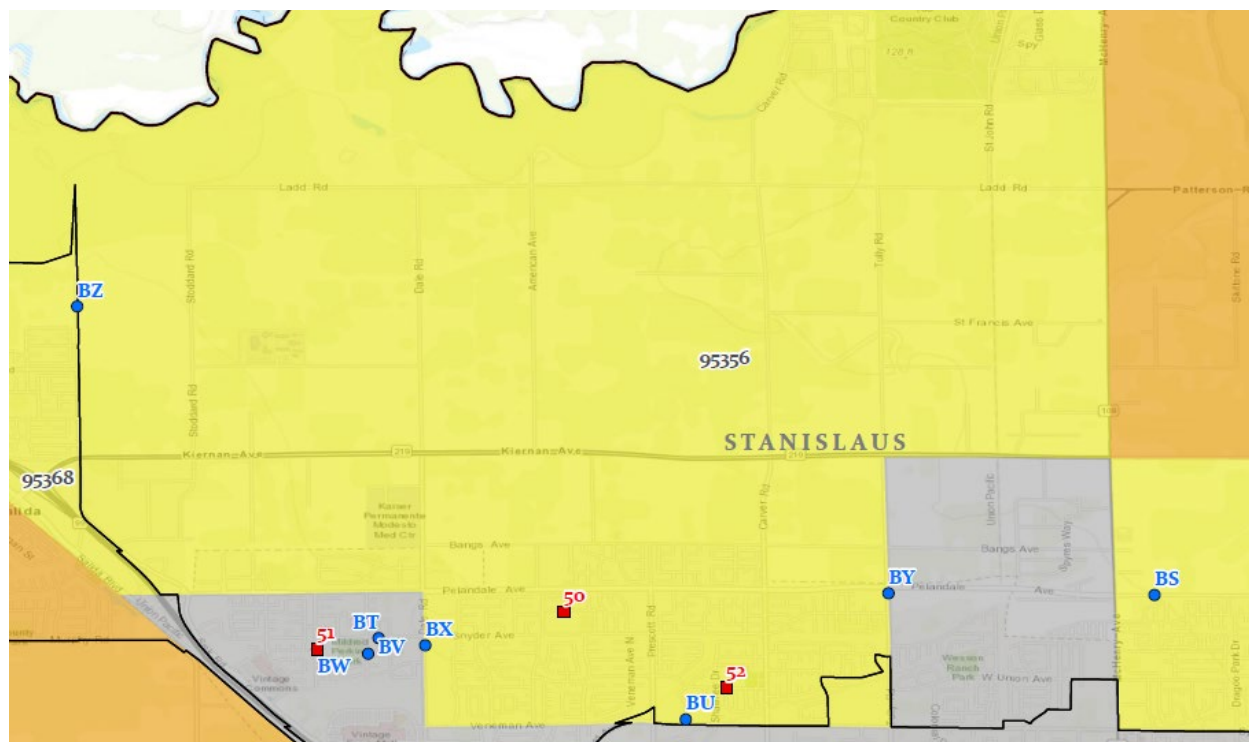

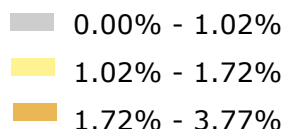

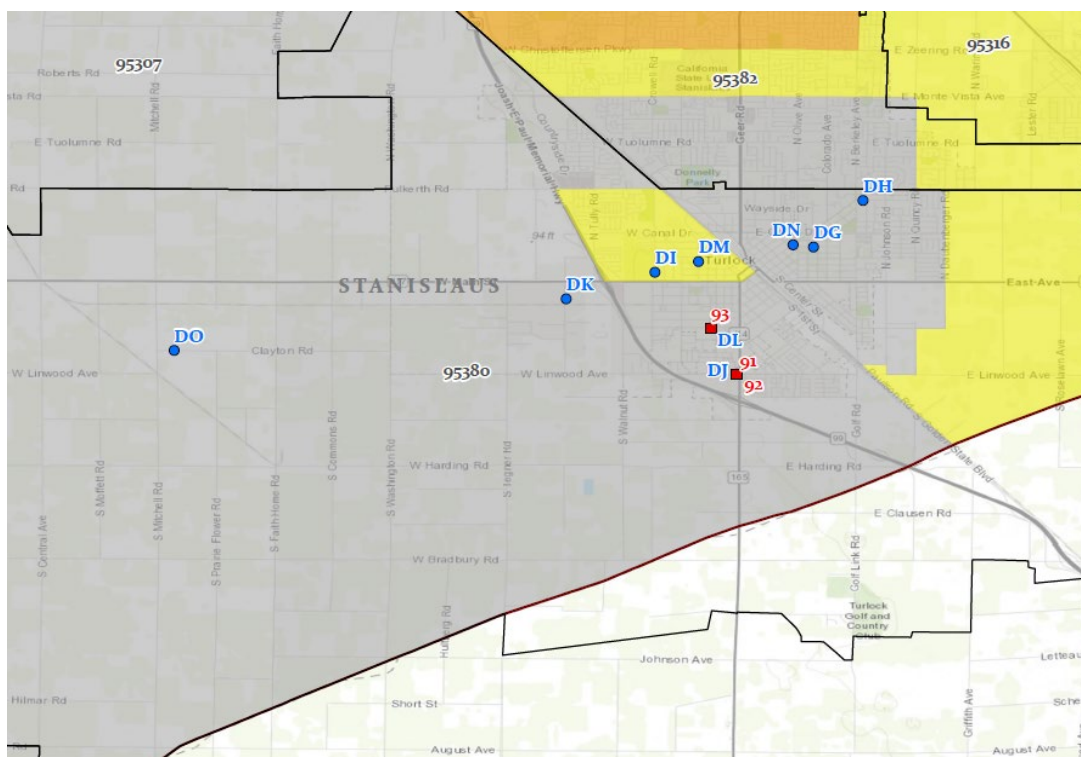

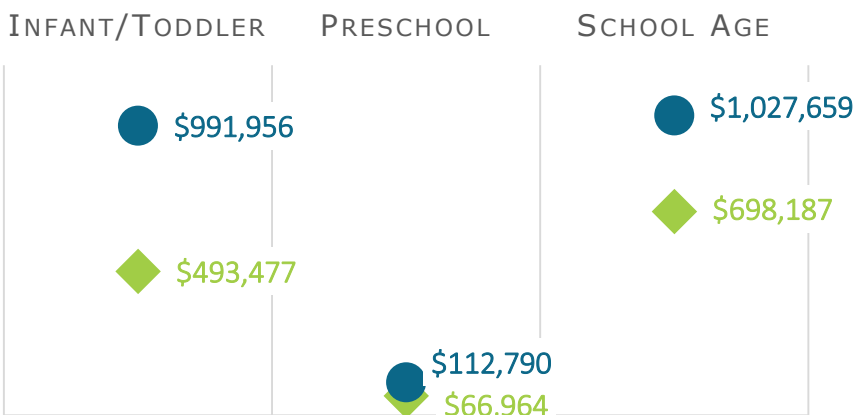

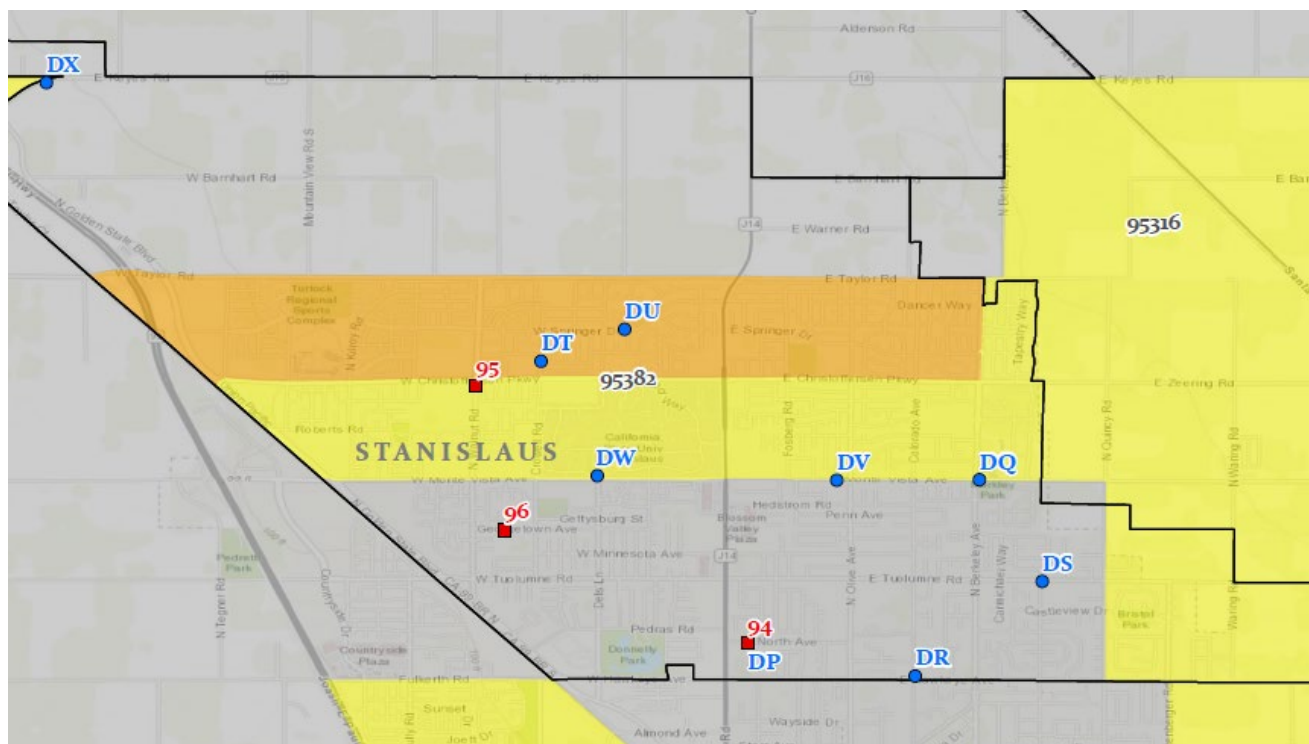

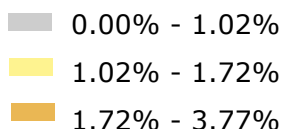

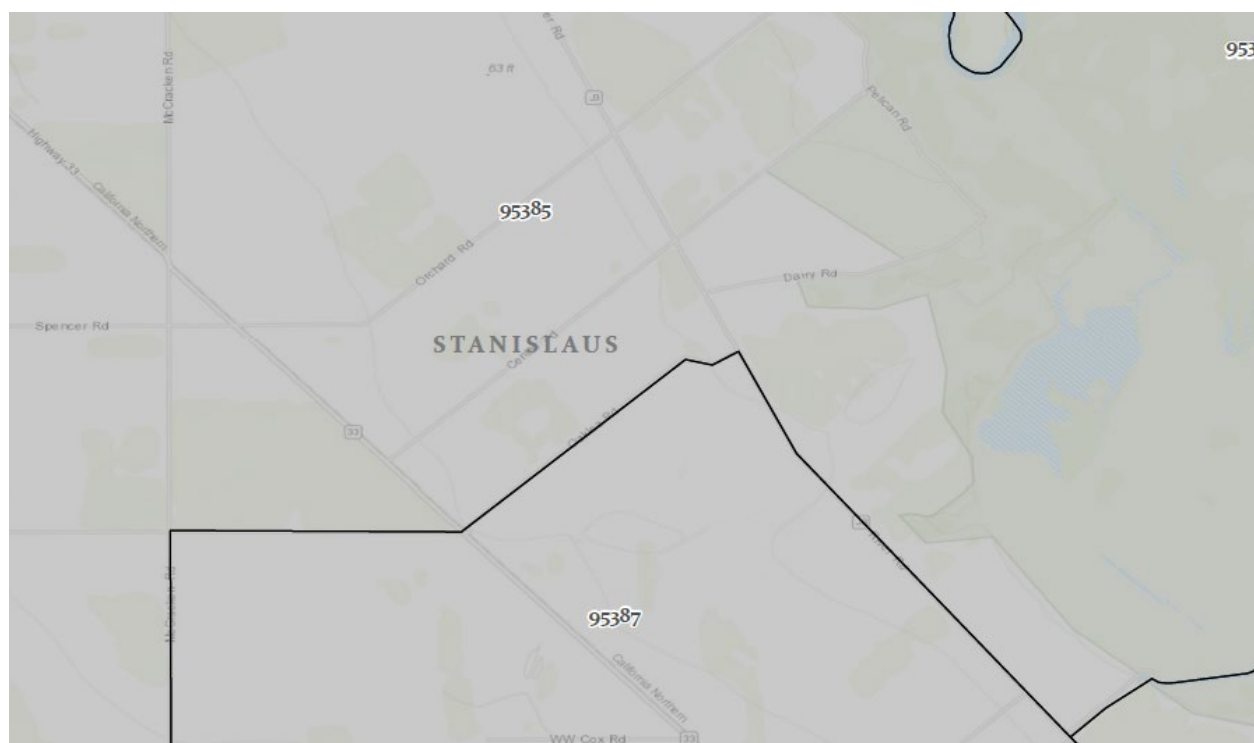

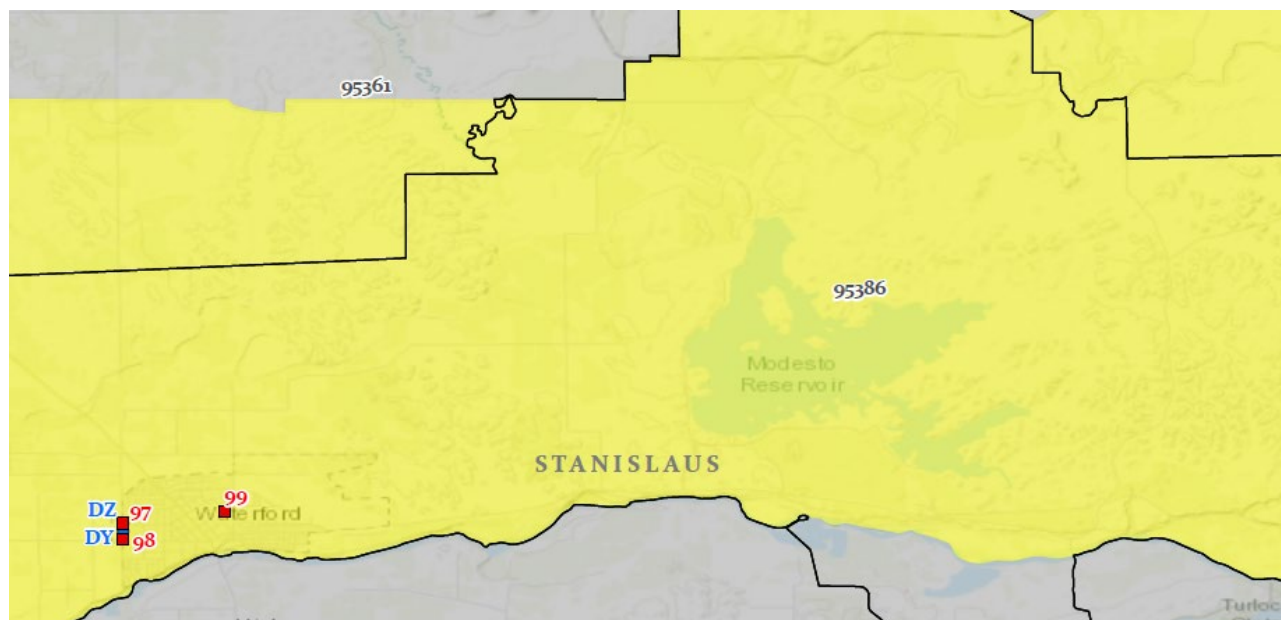

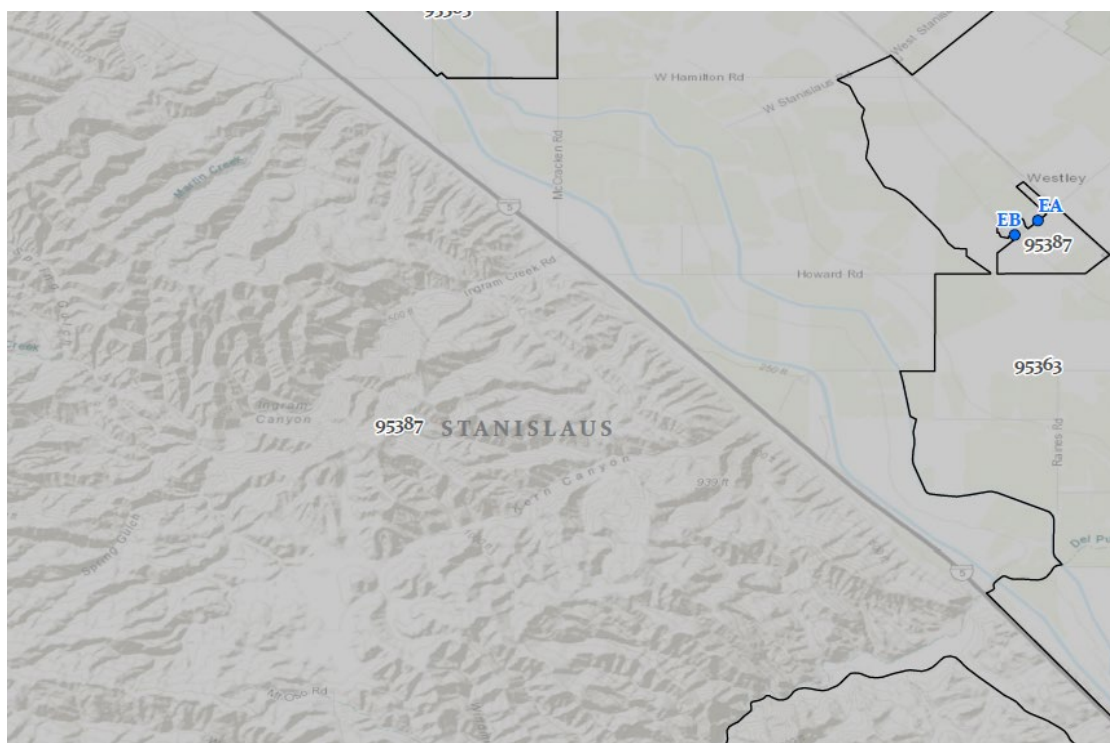

DEFINITION OF TERMS

- A** **Alternative Payment Program** – A state and federally funded program that focuses on parental choice, Child Protective Service (CPS) open case, or identified as at-risk. Income eligible parents are able to use child care services in a child care center, licensed family child care home, or in their own home. Payment for services is made directly to the child care provider.
- C** **California Department of Education** – The department oversees funding and testing, and holds local educational agencies accountable for student achievement. Its stated mission is to provide leadership, assistance, oversight, and resources (via teaching and teaching materials) so that every Californian has access to a good education.
- California State Preschool Program** – Provides full and part day child care services for 3 – 5 year old children. The program focuses on kindergarten readiness. Parents must be income eligible to enroll their children in the program.
- Child Care Center** – Group child care at a facility for children. The maximum number of children that can be cared for at each center is based upon the age group of the children. A facility must be licensed by the California Department of Social Service, Community Care Licensing to serve any age group. Age groups are infants (birth – 18 months), toddlers (18 months – 3 years), preschool (3 – 5 years).
- D** **Demand** – An estimate of the number of children, ages 0-11, living in two parent homes, with both parents in the labor force or in single parent homes, with that parent in the labor force. It does not include parents who have a need for care that is not tied to work; such as a stay-at-home parent who wants their child in a preschool program for educational purposes.
- E** **Early Head Start** – A federally funded comprehensive child development program that serves children birth to three years of age and pregnant women. Comprehensive services include education, health, nutrition, mental health, special education, and family components.
- F** **Family Child Care Home** – Child care that is provided in a home by someone (provider) who is licensed by the California Department of Social Services, Community Care Licensing. Providers are licensed to care for a maximum of eight (small) or fourteen (large) children. A large family child care home must adhere to additional staffing requirements.
- Family, Friends and Neighbors** – Family, friend, and neighbor care is provided in the child's or caregiver's home by a person who is a relative, friend, or neighbor, or a babysitter or nanny. These providers are typically exempt from licensing and regulations. They may not be required to meet health, safety, and training standards unless they care for children who receive government financial assistance.
- Farm Worker Families** – Family units with children where the adult members engage in farm work and may travel within, and/or outside of the county to do so.
- G** **General Child Care** – General child care and development programs are state and federally funded programs that use centers and family child care home networks operated or administered by either public or private agencies and local educational agencies. These agencies provide child development services for children from birth through 12 years of age and older children with exceptional needs. These programs provide an educational component that is developmentally, culturally, and linguistically appropriate for the children served. The programs also provide meals and snacks to children, parent education, referrals to health and social services for families, and staff development opportunities to employees.
- H** **Head Start** – A federally funded comprehensive child development program that serves children three to compulsory school age. Comprehensive services include education, health, nutrition, mental health, special education, and family components.

H

Homeless –The term homeless children and youths –

(A) means individuals who lack a fixed, regular, and adequate nighttime residence (within the meaning of section 103(a)(1)); and

(B) includes –

(i) children and youths who are sharing the housing of other persons due to loss of housing, economic hardship, or a similar reason; are living in motels, hotels, trailer parks, or camping grounds due to the lack of alternative adequate accommodations; are living in emergency or transitional shelters; are abandoned in hospitals; or are awaiting foster care placement;

(ii) children and youths who have a primary nighttime residence that is a public or private place not designed for or ordinarily used as a regular sleeping accommodation for human beings (within the meaning of section 103(a)(2)(C));

(iii) children and youths who are living in cars, parks, public spaces, abandoned buildings, sub-standard housing, bus or train stations, or similar settings; and

(iv) migratory children (as such term is defined in section 1309 of the Elementary and Secondary Education Act of 1965) who qualify as homeless for the purposes of this subtitle because the children are living in circumstances described in clauses (i) through (iii).

M

Migrant and Seasonal Head Start - A federally funded comprehensive child development program that serves children birth to compulsory school age. Comprehensive services include education, health, nutrition, mental health, special education, and family components. In order to qualify, families must meet income guidelines and be a migrant or seasonal farmworker.

Migrant Child Care and Development – Migrant child care and development programs provide services to families who earn at least 50 percent of their total gross income from employment in fishing, agriculture or agriculturally related work during the twelve month period immediately preceding the date of application

Migrant Program (CMIG) – Migrant child care and development programs use centers and family child care home networks operated or administered by either public or private agencies and local educational agencies. These programs provide child development services for children from birth through 12 years of age and older children with exceptional needs. These programs provide an educational component that is culturally, linguistically, and developmentally appropriate for the children served. The programs also provide meals and snacks to children, parent education, referrals to health and social services for agricultural families, and staff development opportunities to employees.

Migrant Alternative Payment Program (CMAP) – Migrant Alternative Payment programs issue vouchers to eligible, migrant families that can be used to purchase child care and development services at legally operating child care providers throughout California's central valley. This program provides services for children birth through 12 years of age, and for older children with exceptional needs. Funding for services follows families as they move from place to place for agricultural work.

S

School Age Program – Many types of programs for school age youth outside the regular school day. Programs typically provide students with a safe, caring, and nurturing place for extended learning and development of social, recreational, and personal life skills during non-school hours. Many programs incorporate a strong partnership of school, family, and community members who contribute to the growth of students as they mature into caring, competent, and responsible adults.

Specific Learning Disability – A disorder in one or more of the basic psychological processes involved in understanding or in using language, spoken or written, which may manifest itself in an imperfect ability to listen, think, speak, read, write, spell, or to do mathematical calculations. The term includes such conditions as perceptual handicaps, brain injury, minimal brain dysfunction, dyslexia, and developmental aphasia. The term does not include children who have learning problems that are primarily the result of visual, hearing, or motor handicaps, of mental retardation of emotional disturbance or of environmental, cultural, or economic disadvantage.

State Subsidized Program – A child care or preschool program that available to children in California. Children must meet all eligibility requirements. Not all programs are available throughout the state. There is no charge for some programs. Other programs require a parent fee that is based upon a fee schedule.

Supply – The number of available child care “slots” to serve children, ranging in age from 0-11 years of age. Formal child care arrangements that include licensed child care centers, family child care homes, and school age centers. It also includes school age centers located on elementary school campuses.

U

Unmet Need– An estimate of the difference between the number of child care slots (supply) to serve the number of parents/guardians who are seeking care for their children (demand). A negative number means that the estimated demand is higher than the estimated supply.
