PARKING RULES – READ CAREFULLY BEFORE SIGNING

STUDENT PARKING IS NOT A RIGHT, BUT A LIMITED PRIVILEGE. THEREFORE, ONLY STUDENTS WHO HAVE BEEN ISSUED A PARKING PERMIT WILL BE ALLOWED TO PARK IN THE DESIGNATED AREAS. DOUBLE PARKING IS NOT ALLOWED. PARKING ALONG CURBS IS NOT ALLOWED. EMERGENCY VEHICLES MUST HAVE FULL ACCESS TO FACILITIES.

BELOW IS A LIST OF RULES AND CONSEQUENCES FOR PARKING:

1. PARKING DECAL MUST HANG ON THE REAR VIEW MIRROR WITH DECAL INFORMATION FACING THE FRONT OF THE VEHICLE. 2. EXIT VEHICLE AND ENTER BUILDING ONCE PARKED. EXIT CAMPUS IMMEDIATELY FOLLOWING THE DISMISSAL BELL.
3. STUDENTS MUST OBSERVE AND PRACTICE SAFE DRIVING RULES. SPEED LIMIT 10MPH.
4. ACCIDENTS OCCURRING IN SCHOOL PARKING AREAS ARE NOT THE RESPONSIBILITY OF WPHS TO REPORT. IT IS THE RESPONSIBILITY OF THE DRIVER(S) INVOLVED.
5. FAILURE TO FOLLOW PARKING AND SAFETY RULES MAY RESULT IN:
 - DISCIPLINARY ACTION
 - THE VEHICLE BEING TOWED AT OWNER'S EXPENSE
 - BANNED FROM DRIVING ON CAMPUS FOR AMOUNT OF TIME DESIGNATED BY ADMINISTRATOR
 - WRITTEN CITATION BY SCHOOL RESOURCE OFFICER
6. YIELD TO PEDESTRIANS.
7. IF ABSENT FROM SCHOOL, STUDENT IS NOT ALLOWED TO WAIT ON OR PICK UP SIBLING(S)/FRIENDS IN THE STUDENT PARKING AREA. USE STUDENT DROP-OFF/PICK-UP AREA ONLY.
8. APPEARING IN THE PARKING LOT WITHOUT PROPER AUTHORIZATION IS A VIOLATION OF THE WPHS CODE OF STUDENT CONDUCT. WRITTEN PERMISSION FROM AN ADMINISTRATOR IS REQUIRED TO ENTER PARKING LOT DURING THE SCHOOL DAY.
9. ANY VEHICLE BROUGHT ON THE WPHS CAMPUS IS SUBJECT TO SEARCH BY ADMINISTRATIVE PERSONNEL (OR DESIGNEE).
10. DO NOT LITTER! LITTERING IN THE PARKING LOT WILL RESULT IN IMMEDIATE DISCIPLINARY ACTION.
11. PLAY MUSIC SO THAT THE VOLUME OF MUSIC CAN ONLY BE HEARD INSIDE THE VEHICLE.
12. REPORT PROBLEMS TO FACULTY, STAFF, OR ADMINISTRATION
