\*\*All fees for the Therapy and Instructional Services shall be annualized and prorated based on the months remaining through the last day in June of each school year and paid monthly throughout the duration of the Term. Sales tax and credit card processing fees will be charged separately, if applicable, and are not included in the fees outlined in this Order Form.

\*\*\*SERVICES STARTED BY DATE. Therapy and Instructional Services will start no later than 42 calendar days (6 weeks) from the date this Order Form is signed or the first day of the School Year, whichever comes last. Implementation starts immediately following the signing of the Agreement, and both Parties will work together in good faith to begin the Therapy and Instructional Services as soon as possible. On average, eLuma implementations take no more than four (4) weeks. If Partner is not ready by the Services Started By Date, eLuma is entitled to full payment in accordance with the Agreement. If eLuma is not ready to start by the Services Started By Date, Partner has one week to elect in writing one of the following options: 1) compensatory time be provided to assigned Students or 2) a prorated credit calculated by eLuma in good faith that will be applied to future orders. If Partner elects compensatory time in writing, eLuma cannot guarantee the same Clinician or schedule availability with respect to the compensatory time. However, eLuma will work to provide compensatory services to assigned Students in a reasonable time frame and in coordination with the Partner.
