Need-Based Financial Aid Information

The Woodlands Christian Academy offers need-based financial aid to support families who show a demonstrated need.

Eligibility

To be eligible for assistance, a family/student must demonstrate financial need, meet the entrance requirements of the Academy, and be current with all financial obligations due. Students enrolling in Pre-K and Kindergarten are not eligible for Financial Aid.

The school does not award merit scholarships based on academic, athletic, or other student talents or achievements.

How to Apply

The Woodlands Christian Academy uses the Grant & Aid Assessment through FACTS, a third-party organization that analyzes the financial situation of applicants based on several factors.

Families applying for Financial Aid must submit their FACTS Grant & Aid Assessment online at: <https://online.factsmgt.com/aid> (866-315-9262).

Need-Based Financial Aid applicants must provide extensive information on their financial position and spending, including but not limited to:

- Prior year federal income tax return and related schedules, and W-2 forms
- Total income for prior year and projected income for current year
- Bank account balances
- Retirement/401K/IRA balances
- Home market value and mortgage balance
- Vehicles make and model and related debt/lease payments
- Credit card and other debt amounts
- Amount spent on discretionary items (e.g. summer camps, sports/music lessons, vacations, country clubs, etc.)

If a federal income tax extension is filed, your application will remain pending until a copy of the return has been submitted. Your application will not be considered until all information is received.



Important Dates

- Dec 1** FACTS Grant & Aid Assessment Application opens.
- Feb 1** Deadline for submitting the FACTS Grant & Aid Assessment Application and Federal Income Tax Return directly to FACTS.
- March** Financial Aid award notifications will be emailed to families that have submitted all required documentation.

Renewals

Need-Based Financial Aid is awarded on an annual basis. Families must reapply each year with current financial information, as awards are not automatically renewed.
