BOARD OF EDUCATION MINUTES – REGULAR MEETING

Tuesday, August 13, 2024, at San Pasqual Union School

- Meeting called to order at 5:10 p.m. to allow public comment on closed session agenda items. Board Members Goe, Murray, and Merz were present. Member Gourley and Baker were not present. Superintendent Burroughs and recording secretary Jenny Grassy were also present. SPETA President and Teacher Mrs. Mallory presented an update on the Local President's Release Grant. Adjourned into Closed Session at 5:17 p.m.

Regular Session

- Meeting called back to order at 5:57 p.m. Members Goe, Merz, and Murray were present. Member Gourley and Baker were not present. Superintendent Burroughs and recording secretary Jenny Grassy were also present.
- Public was welcomed. The flag salute was recited.
- Report from Closed Session. No action was taken on closed session items.

 - Additional training options in 2025
 - Ambassador Program
 - Early stages of building the program
 - Started with family tours, students helping over the summer
 - Library
 - More access for students during lunchtime; restructured library times to allot the time
 - Foundation
 - Shade structure is in with tables set up under it.
 - Teacher grants coming back. The foundation will present at all staff meeting on 8/19.

- Purchased iPads and Chromebooks for school and funded Kagan for staff
 - Continuing WatchDOGS for the 24-25 school year
- PTO
 - Paid for murals in the Barn. Looks amazing!
 - Coffee Cart and breakfast for teachers on 8/16
 - Boohoo/Woohoo on first day for parents
- DELAC
 - Will have table set up on Saints Day to encourage parent involvement

Superintendent's Report:

- Last time we met, we discussed summer plans. Since then we have completed:
 - Lower playground shade structure - Thank you SP, Foundation
 - Glider and slide repairs on lower playground
 - Security camera installation
 - Roof repairs - Major project, 20-year warranty, final inspections pending
 - Reseal center campus
 - Major leak fixed
 - Painting (Buildings 100, 200, 300, 600, 700, K/1 Playground)
 - Restriping parking lots and K/1 playground
 - Playground chip installation
- Still working on:
 - Cleaning/Sanitation of classrooms and common areas
 - Landscaping
 - Classroom & campus preparedness
- Projects coming up:
 - K/1 Playground (still pending DSA approval)
 - Solar Project
 - Currently conducting inspections
 - Trenching could begin as early as this fall
 - Tech infrastructure
 - Received \$80,000 grant to replace current high-speed internet cable with fiber optics

- Hosted initial job walk Friday, likely to start in 6-8 weeks
- School starts 8/21/2024
 - Enrollment as of today 538 students; net increase 14 students since June meeting
 - Activities leading up to start of school: TK and Kinder bootcamp, Saints Day

- Member Goe made a motion to approve the purchase of 10 laptop computers from Dell Technologies. Member Murray seconded the motion. Motion passed 3/0.
- Member Goe made a motion to approve the Resolution #R24-25-0. Member Murray seconded the motion. After further discussion, member Murray made a motion to table Resolution #R24-25-02. Member Goe seconded the motion. Motion passed 3/0.
- Superintendent Burroughs presented the 2022-23 Teaching assignment monitoring outcomes as required.
- Member Goe made a motion to approve the Resolution #R24-25-01. Member Murray seconded the motion. Motion passed 3/0.
- Member Goe made a motion to approve the Policy Manual Changes. Member Murray seconded the motion. Motion passed 3/0.
