All potential bidders are **REQUIRED** to attend this meeting. Subcontractors are encouraged to attend too. Prompt attendance is required, and no bidder will be permitted in the mandatory pre-bid meeting after the meeting has started.

Bids will be received via email to RFX@mpls.k12.mn.us, Ann.Cerney@mpls.k12.mn.us, and cdbergmann@kfi-eng.com by **October 10, 2024 2:00 PM**. (EMAIL TO ALL THREE AT SAME TIME).

Subject line must bear the name of the firm submitting the bid, the Official Publication Number, and the Official Publication Title. Proposals must be typewritten or handwritten, and include handwritten signature in ink. The bidders assume the risk of any delay in the receipt of the bids. The bidder assumes all responsibility for having their bid is delivered by the time specified. The bids will be opened and read aloud by MPS District staff on a Microsoft Teams Meeting on **October 10, 2024 2:30 PM**.

Bids must be accompanied by a bid deposit of 2% of the total amount bid in the form of a certified check or bidder's corporate surety bond made payable to Special School District No. 1. Include a copy of the certified check or bidder's corporate bond when you email your Bid Form.

ONE (1) complete ORIGINAL paper version of proposal, including attachments, is to be **MAILED** to: **Minneapolis Public Schools, Attn: Procurement, 1250 West Broadway Ave, Minneapolis MN 55411**, and must be postmarked within five (5) business days of bid due date.
