Roll Call: Ayes, Steve Corona, Julie Hollingsworth, Jennifer Matthias, Maria Norman, Antonette Payne and Noah Smith, nays, none; Anne Duff abstained from voting.

High Ability Grant 2024-25 Dr. Daniel presented the following recommendation concerning the High Ability Grant 2024-25:

**RECOMMENDATION:** It was recommended that the Board approve the acceptance of a High Ability Grant from the Indiana Department of Education in the amount of \$228,867.00 for the 2024-25 school year.

**RELATED INFORMATION**: The state of Indiana provides non-competitive funds for districts to address the learning needs of high-ability students.

Currently, high-ability services are delivered through the efforts of classroom teachers. The overall program is coordinated by Amelia Pflieger, High Ability, Dual Credit, Advanced Placement, and Internship Manager.

Amelia Pflieger, High Ability, Dual Credit, Advanced Placement & Internship Manager was available to answer questions.

A motion was made by Anne Duff, seconded by Noah Smith, that the recommendation concerning the High Ability Grant 2024-25 be approved. Roll Call: Ayes, unanimous; nays, none.

Dr. Daniel presented the following recommendation concerning the Conscious Discipline Coaching 2024-25:

Conscious Discipline Coaching 2024-25 **RECOMMENDATION:** It was recommended that the Board approve the purchase of In-Person Coaching from Conscious Discipline Master Teachers with Loving Guidance LLC in the amount of \$296,660 for the 2024-25 school year.

**RELATED INFORMATION:** There will be three Master Teachers that will provide coaching in six focus elementary schools, Abbett, Bloomingdale, Indian Village, Shambaugh, South Wayne and Study to continue to assist adults in self-regulation and understanding brain state of themselves and their students. This amount also includes virtual sessions for administrators to support implementation.

The EACH Mental Health Grant will fund these coaching sessions.

Melissa Richards, Director of Well-being and Alternative Programs was available to answer questions.

A motion was made by Julie Hollingsworth, seconded by Anne Duff, that the recommendation concerning the Conscious Discipline Coaching 2024-25 be approved. Roll Call: Ayes, unanimous; nays, none.

Handheld Radios and Repeaters Dr. Daniel presented the following recommendation concerning the Handheld Radios and Repeaters:

**RECOMMENDATION:** It was recommended that the Board approve the purchase of handheld radios and repeaters from J & K Communications, Inc. of Columbia City, IN in the amount of \$164,101.54.

RELATED INFORMATION: This purchase will replace handheld radios at 10 schools: Northrop, South Side, Kekionga, Abbett, Bloomingdale, Fairfield, Harrison Hill, Nebraska/CAS, Northcrest and South Wayne. Repeaters will be replaced at five schools: North Side, Northrop, Snider, South Side and Anthis Career Center. In addition, a new repeater will be installed at Nutrition Services. The upgraded handheld radios and repeaters will have wider range and higher communication resolution.

Funding will come from the School Safety Operations Referendum Fund.

Michael Manuel, Director of Security, was available to answer questions.

A motion was made by Anne Duff, seconded by Julie Hollingsworth, that the recommendation concerning the Handheld Radios and Repeaters be approved. Roll Call: Ayes, unanimous; nays, none.

School Resource Officer Program Dr. Daniel presented the following recommendation concerning the School Resource Officer Program:

**RECOMMENDATION:** It was recommended that the Board approve an agreement between the Fort Wayne Police Department (FWPD) and FWCS for continuation of the School Resource Officer Program for 2024 in the amount of \$254,440.

**RELATED INFORMATION:** This Program includes eight full-time trained FWPD police officers and will assign an officer at the following middle schools: Jefferson, Kekionga, Lakeside, Memorial Park, Northwood, Lane, Blackhawk and Portage.

Funding will come from the Operations Fund and the Secured School Safety Grant.

Michael Manuel, Director of Security, was available to answer questions.

A motion was made by Jennifer Matthias, seconded by Anne Duff, that the recommendation concerning the School Resource Officer Program be approved. Roll Call: Ayes, unanimous; nays, none.

Student Services at FACE Presentation An overview of the Student Service department's daily functions was presented. Valuable insights were provided into the services and the successful strategies implemented to ensure all families and students are helped accordingly. A video was shown.
