

**PEQUEA VALLEY SCHOOL BOARD**  
**Committee Meeting**  
**September 3, 2024**

The monthly Committee meeting of the Pequea Valley School Board was called to order by President Bryant Ferris at 7:00 p.m. Members present were Michael Fisher, Mike Hartmann, Freida Huyard, Ben Ingles, Steve Riehl, and Casey Rohrer, Fred Hertzler and Steve Temple were absent. **Building Project Update** – Fred Kendall provided an update on the middle/high school construction project which is 84% complete. Seth Wentz of Crabtree Rohrbach and Associates presented an update on Phase 2 of the project.

**Enrollment Update** – Erik Orndorff presented district enrollment data. He mentioned the 7-12 consolidation due to the decrease in enrollment.
