

## **Fee Waiver Application**

## Read the fee waiver eligibility guidelines before filling out the application.

**SAT** fee waivers are available to low-income 11th- and 12th-grade students in the U.S. or U.S. territories. U.S. citizens living outside the country might also be eligible for fee waivers.

You're eligible if one or more of these descriptions apply to you:

- □ You're enrolled in or eligible to participate in the federal National School Lunch Program (NSLP).
- ☐ Your family's annual income falls within the <u>Income Eligibility Guidelines</u> set by the United States Department of Agriculture (USDA) Food and Nutrition Service.
- □ You're enrolled in a federal, state, or local program that aids students from low-income families, for example, TRIO programs like Upward Bound.
- □ Your family receives public assistance.
- □ You're homeless or live in federally subsidized public housing or a foster home.
- □ You're a ward of the state or an orphan.

**ACT** offers a test fee waiver program to eligible students that covers the regular registration fee and late fees, and provides additional benefits. To receive a fee waiver, a student must:

- 1. Be currently enrolled in the 11th or 12th grade.
- 2. Test in the United States, US territories, or Puerto Rico.
- 3. Meet one or more of the following indicators of economic need:
  - Enrolled in a federal free or reduced-price lunch program at school
  - □ Enrolled in a program for the economically disadvantaged (for example, a federally funded program such as GEAR UP or Upward Bound) Note: Program participants who are not economically disadvantaged are not eligible for a fee waiver.
  - Resides in a foster home, is a ward of the state, or is homeless
  - Family receives low-income public assistance or lives in federally subsidized public housing.

Family's total annual income is at or below the USDA levels for free or reduced-price lunches listed on the USDA Food and Nutrition Service website: https://www.fns.usda.gov/schoolmeals/income-eligibility-guidelines
