The San Benito County Office of Education evaluated its stakeholder engagement opportunities and determined that Tribes are neither present nor served by the LEA.

A description of how the development of the plan was influenced by community input.

A detailed description of each of the plans were shared with all stakeholders and listed is the feedback from each group:

Students: A safe campus, safe space for communicating social/emotional issues, field trips and on campus student activities such as lunch time activities and clubs, continued academic support during the school day and after school, continued mental health check ins.

Families, including families that speak languages other than English; Small class sizes for the space that exists, continued communication with the school and staff, career and college connections and opportunities and awareness of volunteer opportunities in the community

School and district administrators, including special education administrators: Continue opportunities for academic assistance for students and provided social emotional support for students and staff. The continuation of safety procedures and training was also vital to keep all students and staff safe.

Teachers, principals, school leaders, other educators, school staff, and local bargaining units: Possible shade structures between the buildings for students at lunch and morning break, including STEM enrichment activities with Art enrichment, activities for students such as athletics or clubs, provide Trauma Informed and SEL trainings to all staff, hire an additional part-time teacher and add additional instructional aide time

Community Organizations: Enrichment activities and clubs for the students during the school day and after school.

A summary of the feedback was to continue to offer the academic and social emotional supports in place and expand those supports. Expand the enrichment and activities for students. Provide connections for students to employment opportunities, volunteer work and support of the community. Continue communication with parents and ensure all staff receive professional development training around Social Emotional Learning and Trauma Informed practices.

The following feedback influenced the development of the plan. Stakeholders wanted to continue the safety procedures in place, continue with the Summer School and social emotional support with the School Social Worker. The support of the Arts implementation was also stated by multiple stakeholders.

ESSER III Expenditure Plan Instructions

Introduction

School districts, county offices of education (COEs), or charter schools, collectively known as local educational agencies (LEAs), that receive Elementary and Secondary School Emergency Relief (ESSER) funds under the American Rescue Plan (ARP) Act, referred to as ESSER III funds, are required to develop a plan for how they will use ESSER III funds to, at a minimum, address students' academic, social, emotional, and mental health needs, as well as the opportunity gaps that existed before, and were exacerbated by, the COVID-19 pandemic.

The plan must be adopted by the local governing board or body of the LEA at a public meeting on or before October 29, 2021 and must be submitted for review and approval within five days of adoption. A school district must submit its ESSER III Expenditure Plan to its COE for review and approval; a COE must submit its plan to the California Department of Education for review and approval. A charter school must submit its plan to its chartering authority for review and to the COE of the county in which the charter school operates for review and approval.

In addition, consistent with the requirements of the ARP, Volume 86, *Federal Register*, page 21201, April 22, 2021, the ESSER III Expenditure Plan must be:

- Written in an understandable and uniform format;
- Written in a language that parents can understand, to the extent practicable;
 - If it is not practicable to provide written translations to a parent with limited English proficiency, the plan must be orally translated for parents
- Provided in an alternative format to a parent who is an individual with a disability as defined by the Americans with Disabilities Act, upon request; and
- Be made publicly available on the LEA's website.

 - **Tier 3 – Promising Evidence:** the effectiveness of the practices or programs is supported by one or more well-designed and well-implemented correlational studies (with statistical controls for selection bias).
 - **Tier 4 – Demonstrates a Rationale:** practices that have a well-defined logic model or theory of action, are supported by research, and have some effort underway by a State Educational Agency, LEA, or outside research organization to determine their effectiveness.

 - Planning and implementing activities related to summer learning and supplemental after school programs, including providing classroom instruction or online learning during the summer months and addressing the needs of underserved students;

- Addressing learning loss among students, including underserved students, by:
 - Administering and using high-quality assessments that are valid and reliable, to accurately assess students' academic progress and assist educators in meeting students' academic needs, including through differentiated instruction,
 - Implementing evidence-based activities to meet the comprehensive needs of students,
 - Providing information and assistance to parents and families of how they can effectively support students, including in a distance learning environment, and
 - Tracking student attendance and improving student engagement in distance education;

Note: A definition of “underserved students” is provided in the Community Engagement section of the instructions.

- School facility repairs and improvements to enable operation of schools to reduce risks of virus transmission and exposure to environmental health hazards, and to support student health needs;
- Inspection, testing, maintenance, repair, replacement, and upgrade projects to improve the indoor air quality in school facilities, including mechanical and nonmechanical heating, ventilation, and air conditioning systems, filtering, purification and other air cleaning, fans, control systems, and window and door replacement;
- Developing strategies and implementing public health protocols including, to the greatest extent practicable, policies in line with guidance from the Centers for Disease Control and Prevention (CDC) for the reopening and operation of school facilities to effectively maintain the health and safety of students, educators, and other staff;
- Other activities that are necessary to maintain the operation of and continuity of services in LEAs and continuing to employ existing staff of the LEA.
