<p>Cienega Union Elementary School District involved parents, teachers, and school staff in the development of Extended Learning Opportunities plan by providing the following engagement opportunities:</p> <ul style="list-style-type: none"> • School Staff Meetings (3/12/21, 4/16/19, 4/30/21, 5/14/21) • School Site Council Meeting (5/18/21) • Parent Survey (April 2021) • Staff Survey (April 2021) • Student Survey (April 2021) <p>Parents, staff, and students identified the small school atmosphere, low student to teacher ratio, and differentiated instruction as strengths of the LEA.</p> <p>Parents identified updated curriculum, supplemental academic supports, in-person mental health services as areas for improvement. Staff members identified increased professional development opportunities, after-school targeted intervention and student support, and improved/updated curriculum as areas for growth. Students identified in-person counseling and improved physical education equipment as areas for growth. All groups (parents, staff, and students agreed that in-person instruction was the most effective learning model.</p>

Cienega Union Elementary School District will identify student academic needs using several different methods. All students will take the Star 360 assessment in both math and ELA five times throughout the year. In July, the initial results will be used as diagnostic and data collected will guide initial interventions and small-group instruction. To measure progress throughout the year, students will take the Star 360 assessments again in October, December, March, and May. Test results from standards-based curriculum and instructor developed assessments may also be used to gauge areas of strengths and growth for students. Additionally, results from the English Literacy Proficiency Assessment for California (ELPAC) and California Assessment of Student Performance and Progress (CAASPP) will be used to identify students with specific learning needs.

To assess students with needs for mental health support, the district will utilize attendance records and classroom behavior observations.

Cienega Union Elementary School District communicates frequently with parents through our weekly "Tuesday Telegram" newsletter, emails, text messages, and phone calls. Information about supplemental programs will be available in our Back-to-School packet, during parent-teacher conferences, IEP meetings, and other school activities. If a family is not utilizing the support offered by the district, or if the student is needing additional support, individual parent-teacher-administration meetings will be scheduled.

Cienega Union Elementary School District plans to utilize the Expanded Learning Opportunity grant funds to provide the following supports:

- Increased hours for our paraprofessional team to provide after-school interventions for students.
- Upgrades to ELA and Math materials and curriculums
- Supplemental ELA online support programming
- Updated Social Studies curriculum
- Internet Hotspots for families in need
- Professional development for paraprofessionals and certificated staff in the areas of literacy, arts, mathematics, and trauma informed practices
- Contracted services with the San Benito County Office of Education for in-person mental health services and family education

Expanded Learning Opportunities Grant Plan Instructions: Introduction

The Expanded Learning Opportunities Grant Plan must be completed by school districts, county offices of education, or charter schools, collectively referred to as Local Educational Agencies (LEAs), that receive Expanded Learning Opportunities (ELO) Grant funds under California *Education Code (EC)* Section 43521(b). The plan must be adopted by the local governing board or body of the LEA at a public meeting on or before June 1, 2021, and must be submitted to the county office of education, the California Department of Education, or the chartering authority within five days of adoption, as applicable. The plan must be updated to include the actual expenditures by December 1, 2022.

Instructions: Plan Requirements

An LEA receiving ELO Grant funds under *EC* Section 43521(b) is required to implement a learning recovery program that, at a minimum, provides supplemental instruction, support for social and emotional well-being, and, to the maximum extent permissible under the guidelines of the United States Department of Agriculture, meals and snacks to, at a minimum, students who are included in one or more of the following groups:

- low-income,
- English learners,
- foster youth,
- homeless students,
- students with disabilities,
- students at risk of abuse, neglect, or exploitation,
- disengaged students, and
- students who are below grade level, including, but not limited to, those who did not enroll in kindergarten in the 2020–21 school year, credit-deficient students, high school students at risk of not graduating, and other students identified by certificated staff.

For purposes of this requirement

- “Supplemental instruction” means the instructional programs provided in addition to and complementary to the LEAs regular instructional programs, including services provided in accordance with an individualized education program (IEP).
- “Support” means interventions provided as a supplement to those regularly provided by the LEA, including services provided in accordance with an IEP, that are designed to meet students’ needs for behavioral, social, emotional, and other integrated student supports, in order to enable students to engage in, and benefit from, the supplemental instruction being provided.
- “Students at risk of abuse, neglect, or exploitation” means students who are identified as being at risk of abuse, neglect, or exploitation in a written referral from a legal, medical, or social service agency, or emergency shelter.

EC Section 43522(b) identifies the seven supplemental instruction and support strategies listed below as the strategies that may be supported with ELO Grant funds and requires the LEA to use the funding only for any of these purposes. LEAs are not required to implement each supplemental instruction and support strategy; rather LEAs are to work collaboratively with their community partners to identify the

supplemental instruction and support strategies that will be implemented. LEAs are encouraged to engage, plan, and collaborate on program operation with community partners and expanded learning programs, and to leverage existing behavioral health partnerships and Medi-Cal billing options in the design and implementation of the supplemental instruction and support strategies being provided (*EC* Section 43522[h]).

The seven supplemental instruction and support strategies are:

1. Extending instructional learning time in addition to what is required for the school year by increasing the number of instructional days or minutes provided during the school year, providing summer school or intersessional instructional programs, or taking any other action that increases the amount of instructional time or services provided to students based on their learning needs.
2. Accelerating progress to close learning gaps through the implementation, expansion, or enhancement of learning supports including, but not limited to, any of the following:
 - a. Tutoring or other one-on-one or small group learning supports provided by certificated or classified staff.
 - b. Learning recovery programs and materials designed to accelerate student academic proficiency or English language proficiency, or both.
 - c. Educator training, for both certificated and classified staff, in accelerated learning strategies and effectively addressing learning gaps, including training in facilitating quality and engaging learning opportunities for all students.
3. Integrated student supports to address other barriers to learning, such as the provision of health, counseling, or mental health services, access to school meal programs, before and after school programs, or programs to address student trauma and social-emotional learning, or referrals for support for family or student needs.
4. Community learning hubs that provide students with access to technology, high-speed internet, and other academic supports.
5. Supports for credit deficient students to complete graduation or grade promotion requirements and to increase or improve students' college eligibility.
6. Additional academic services for students, such as diagnostic, progress monitoring, and benchmark assessments of student learning.
7. Training for school staff on strategies, including trauma-informed practices, to engage students and families in addressing students' social-emotional health needs and academic needs.

As a reminder, *EC* Section 43522(g) requires that all services delivered to students with disabilities be delivered in accordance with an applicable IEP.

Fiscal Requirements

The following fiscal requirements are requirements of the ELO grant, but they are not addressed in this plan. Adherence to these requirements will be monitored through the annual audit process.

- The LEA must use at least 85 percent (85%) of its apportionment for expenditures related to providing in-person services in any of the seven purposes described above.
- The LEA must use at least 10 percent (10%) of the funding that is received based on LCFF entitlement to hire paraprofessionals to provide supplemental instruction and support through the duration of this program, with a priority for full-time paraprofessionals. The supplemental instruction and support provided by the paraprofessionals must be prioritized for English learners and students with disabilities. Funds expended to hire paraprofessionals count towards the LEAs requirement to spend at least 85% of its apportionment to provide in-person services.

- An LEA may use up to 15 percent (15%) of its apportionment to increase or improve services for students participating in distance learning or to support activities intended to prepare the LEA for in-person instruction, before in-person instructional services are offered.
