The following is the local educational agency’s (LEA’s) plan for providing supplemental instruction and support to students, including those identified as needing academic, social-emotional, and other supports, including the provision of meals and snacks. ## Plan Descriptions

A description of how parents, teachers, and school staff were involved in the development of the plan.

Jefferson Elementary is a K-8 school with six students currently enrolled, two staff members, and five families. Because of our size, we are able to personally connect with each member of our community. The plan was shared with the parents and students through phone calls and direct meetings during the months of April and May. In addition, the Teacher/Principal met with each family through telephone, direct contact, emails, and surveys. The results of these discussions and meetings were that while the families were happy with the amount of instructional time their children received during the 2020-2021 school year from the Jefferson staff, and they were interested in their children attending a summer school program. A couple of the families expressed a desire for their child to receive counseling to help with their child's social-emotional regulation. The two staff members (Teacher/Principal and Instructional Aid) meet on a daily basis, both before, during, and after school to discuss the different aspects as of the plan as it continued to emerge. The Teacher/Principal also met with colleagues at the San Benito County Office of Education as well other rural Principals. Through these meetings, she received input from the SBCOE on what and how the funds could be spent. She participated in discussions and trainings about the need for a counselor at the different rural schools in the county and how the resources could be combined to provide counseling services to the students and the families.

A description of how students will be identified and the needs of students will be assessed.

The students in need of counseling services will be identified based on staff observation and conferences with the family. These students will benefit from individual and group counseling sessions which means that all students will participate in classroom lessons to support the students. This will also help ensure that no single student feels "singled" out and that all students will benefit from developing social emotional skills. Academic progress will be monitored through STAR 360 ELA and math assessments. Social emotional progress will be monitored through the teacher, parents, student(s), and Social Worker.

A description of how parents and guardians of students will be informed of the opportunities for supplemental instruction and support.

The parents will be informed through direct conversations, flyers, samples of the work sent home on a weekly basis, a school newsletter and Parent Teacher conferences that occur each trimester.

A description of the LEA's plan to provide supplemental instruction and support.

1. Jefferson Elementary will hire a Social Worker to provide individual and group counseling sessions centered around developing Social Emotional Learning Skills. The Social Worker will work for two hours a week for 35 weeks out of the school year.
2. Jefferson Elementary will provide a summer school program utilizing Core and supplemental materials, primarily Imagine Learning Math Facts and Imagine Learning Language and Literacy. Students will attend summer school for four days a week, Monday through Thursday from 8:30 to 11:30 A.M. The summer school session will begin June 22 and end on July 8. The Imagine Learning programs will then serve as supplemental materials for intervention services during the 2021-2022 school year.
3. The Instructional Aid will increase her time with the students for an extra hour each week. The instructional focus for this extra hour will be math fluency using the Imagine Learning Math Facts program.

# Expanded Learning Opportunities Grant Plan Instructions: Introduction

The Expanded Learning Opportunities Grant Plan must be completed by school districts, county offices of education, or charter schools, collectively referred to as Local Educational Agencies (LEAs), that receive Expanded Learning Opportunities (ELO) Grant funds under California *Education Code (EC)* Section 43521(b). The plan must be adopted by the local governing board or body of the LEA at a public meeting on or before June 1, 2021, and must be submitted to the county office of education, the California Department of Education, or the chartering authority within five days of adoption, as applicable. The plan must be updated to include the actual expenditures by December 1, 2022.

## Instructions: Plan Requirements

An LEA receiving ELO Grant funds under *EC* Section 43521(b) is required to implement a learning recovery program that, at a minimum, provides supplemental instruction, support for social and emotional well-being, and, to the maximum extent permissible under the guidelines of the United States Department of Agriculture, meals and snacks to, at a minimum, students who are included in one or more of the following groups:

- low-income,
- English learners,
- foster youth,
- homeless students,
- students with disabilities,
- students at risk of abuse, neglect, or exploitation,
- disengaged students, and
- students who are below grade level, including, but not limited to, those who did not enroll in kindergarten in the 2020–21 school year, credit-deficient students, high school students at risk of not graduating, and other students identified by certificated staff.

For purposes of this requirement

- “Supplemental instruction” means the instructional programs provided in addition to and complementary to the LEAs regular instructional programs, including services provided in accordance with an individualized education program (IEP).
- “Support” means interventions provided as a supplement to those regularly provided by the LEA, including services provided in accordance with an IEP, that are designed to meet students’ needs for behavioral, social, emotional, and other integrated student supports, in order to enable students to engage in, and benefit from, the supplemental instruction being provided.
- “Students at risk of abuse, neglect, or exploitation” means students who are identified as being at risk of abuse, neglect, or exploitation in a written referral from a legal, medical, or social service agency, or emergency shelter.

*EC* Section 43522(b) identifies the seven supplemental instruction and support strategies listed below as the strategies that may be supported with ELO Grant funds and requires the LEA to use the funding only for any of these purposes. LEAs are not required to implement each supplemental instruction and support strategy; rather LEAs are to work collaboratively with their community partners to identify the

supplemental instruction and support strategies that will be implemented. LEAs are encouraged to engage, plan, and collaborate on program operation with community partners and expanded learning programs, and to leverage existing behavioral health partnerships and Medi-Cal billing options in the design and implementation of the supplemental instruction and support strategies being provided (*EC* Section 43522[h]).

The seven supplemental instruction and support strategies are:

1. Extending instructional learning time in addition to what is required for the school year by increasing the number of instructional days or minutes provided during the school year, providing summer school or intersessional instructional programs, or taking any other action that increases the amount of instructional time or services provided to students based on their learning needs.
2. Accelerating progress to close learning gaps through the implementation, expansion, or enhancement of learning supports including, but not limited to, any of the following:
  - a. Tutoring or other one-on-one or small group learning supports provided by certificated or classified staff.
  - b. Learning recovery programs and materials designed to accelerate student academic proficiency or English language proficiency, or both.
  - c. Educator training, for both certificated and classified staff, in accelerated learning strategies and effectively addressing learning gaps, including training in facilitating quality and engaging learning opportunities for all students.
3. Integrated student supports to address other barriers to learning, such as the provision of health, counseling, or mental health services, access to school meal programs, before and after school programs, or programs to address student trauma and social-emotional learning, or referrals for support for family or student needs.
4. Community learning hubs that provide students with access to technology, high-speed internet, and other academic supports.
5. Supports for credit deficient students to complete graduation or grade promotion requirements and to increase or improve students' college eligibility.
6. Additional academic services for students, such as diagnostic, progress monitoring, and benchmark assessments of student learning.
7. Training for school staff on strategies, including trauma-informed practices, to engage students and families in addressing students' social-emotional health needs and academic needs.

As a reminder, *EC* Section 43522(g) requires that all services delivered to students with disabilities be delivered in accordance with an applicable IEP.

### **Fiscal Requirements**

The following fiscal requirements are requirements of the ELO grant, but they are not addressed in this plan. Adherence to these requirements will be monitored through the annual audit process.

- The LEA must use at least 85 percent (85%) of its apportionment for expenditures related to providing in-person services in any of the seven purposes described above.
- The LEA must use at least 10 percent (10%) of the funding that is received based on LCFF entitlement to hire paraprofessionals to provide supplemental instruction and support through the duration of this program, with a priority for full-time paraprofessionals. The supplemental instruction and support provided by the paraprofessionals must be prioritized for English learners and students with disabilities. Funds expended to hire paraprofessionals count towards the LEAs requirement to spend at least 85% of its apportionment to provide in-person services.

- An LEA may use up to 15 percent (15%) of its apportionment to increase or improve services for students participating in distance learning or to support activities intended to prepare the LEA for in-person instruction, before in-person instructional services are offered.
