Based on the needs in the stakeholder meetings held in 2020, School Site Council Meetings in 2020-2021, the 7th/8th grade student survey in 2021, and the teacher planning meetings in 2021, the Expanded Learning Plan was developed. The Expanded Learning Opportunities Grant was developed with students as the focus and after reviewing academic data from the 2020-2021 school year. It is vital that students' academic, social and emotional needs are provided during the school day as well as after school. The plan takes into account our English Learners, low income students, foster youth, students with disabilities, and students who struggled during the Distance Learning and hybrid in-person learning from March 2020-June 2021.

A description of how students will be identified and the needs of students will be assessed.

Students who will need support through the Expanded Learning Opportunities Grant have been identified based on data gathered during the 2020-2021 school year which include: i-Ready results in Reading and Math (1st-8th grade), Reading Results (TK-3rd grade), ESGI common assessments in ELA and Math (TK-K), District Writing Assessments (TK-8th grade), and grade level common formative assessments. Students who are low income, Foster Youth, English Learners, and Students with Disabilities will have the highest priority. Assessments will be ongoing throughout the school year and also during Summer School. A screening assessment will also be given to determine Social Emotional Learning needs of students.

Parents and guardians of students will be informed of additional supplemental instruction through personal invitations, Parent/Teacher conferences in the fall and spring, flyers, emails, phone calls, and the monthly Tiger Talks. Communication will be provided in both English and Spanish.

A description of the LEA's plan to provide supplemental instruction and support.

The Supplemental instruction and support will include the following:
Push in intervention in TK-5th grade during core instruction daily.
After School Intervention in 1st-3rd grade two days per week with progress monitoring.
After School Tutoring in 4th-8th grade two days per week.
Saturday School for 2nd -8th grade once a month.
Summer School for TK-7th grade.
Small group differentiated instruction in all classes as a Tier 1 and Tier 2 model.
i-ready reading and math during school and at home for TK-8th grade.
Supplemental materials to support in person instruction.
ROAR teacher to support students who are learning from home. (Daily interaction)

The ELO Grant funds are being used to in coordination with ESSER to provide expanded learning opportunities such as, Summer School, Interventions, Saturday School along with Expanded Mental Health services.

Expanded Learning Opportunities Grant Plan Instructions: Introduction

The Expanded Learning Opportunities Grant Plan must be completed by school districts, county offices of education, or charter schools, collectively referred to as Local Educational Agencies (LEAs), that receive Expanded Learning Opportunities (ELO) Grant funds under California *Education Code (EC)* Section 43521(b). Instructions: Plan Requirements

An LEA receiving ELO Grant funds under *EC* Section 43521(b) is required to implement a learning recovery program that, at a minimum, provides supplemental instruction, support for social and emotional well-being, and, to the maximum extent permissible under the guidelines of the United States Department of Agriculture, meals and snacks to, at a minimum, students who are included in one or more of the following groups:

- low-income,
- English learners,
- foster youth,
- homeless students,
- students with disabilities,
- students at risk of abuse, neglect, or exploitation,
- disengaged students, and
- students who are below grade level, including, but not limited to, those who did not enroll in kindergarten in the 2020–21 school year, credit-deficient students, high school students at risk of not graduating, and other students identified by certificated staff.

For purposes of this requirement

- “Supplemental instruction” means the instructional programs provided in addition to and complementary to the LEAs regular instructional programs, including services provided in accordance with an individualized education program (IEP).
- “Support” means interventions provided as a supplement to those regularly provided by the LEA, including services provided in accordance with an IEP, that are designed to meet students’ needs for behavioral, social, emotional, and other integrated student supports, in order to enable students to engage in, and benefit from, the supplemental instruction being provided.
- “Students at risk of abuse, neglect, or exploitation” means students who are identified as being at risk of abuse, neglect, or exploitation in a written referral from a legal, medical, or social service agency, or emergency shelter.

EC Section 43522(b) identifies the seven supplemental instruction and support strategies listed below as the strategies that may be supported with ELO Grant funds and requires the LEA to use the funding only for any of these purposes. LEAs are not required to implement each supplemental instruction and support strategy; rather LEAs are to work collaboratively with their community partners to identify the

supplemental instruction and support strategies that will be implemented. LEAs are encouraged to engage, plan, and collaborate on program operation with community partners and expanded learning programs, and to leverage existing behavioral health partnerships and Medi-Cal billing options in the design and implementation of the supplemental instruction and support strategies being provided (*EC* Section 43522[h]).

The seven supplemental instruction and support strategies are:

1. Extending instructional learning time in addition to what is required for the school year by increasing the number of instructional days or minutes provided during the school year, providing summer school or intersessional instructional programs, or taking any other action that increases the amount of instructional time or services provided to students based on their learning needs.
2. Accelerating progress to close learning gaps through the implementation, expansion, or enhancement of learning supports including, but not limited to, any of the following:
 - a. Tutoring or other one-on-one or small group learning supports provided by certificated or classified staff.
 - b. Learning recovery programs and materials designed to accelerate student academic proficiency or English language proficiency, or both.
 - c. Educator training, for both certificated and classified staff, in accelerated learning strategies and effectively addressing learning gaps, including training in facilitating quality and engaging learning opportunities for all students.
3. Integrated student supports to address other barriers to learning, such as the provision of health, counseling, or mental health services, access to school meal programs, before and after school programs, or programs to address student trauma and social-emotional learning, or referrals for support for family or student needs.
4. Community learning hubs that provide students with access to technology, high-speed internet, and other academic supports.
5. Supports for credit deficient students to complete graduation or grade promotion requirements and to increase or improve students' college eligibility.
6. Additional academic services for students, such as diagnostic, progress monitoring, and benchmark assessments of student learning.
7. Training for school staff on strategies, including trauma-informed practices, to engage students and families in addressing students' social-emotional health needs and academic needs.

As a reminder, *EC* Section 43522(g) requires that all services delivered to students with disabilities be delivered in accordance with an applicable IEP.

Fiscal Requirements

The following fiscal requirements are requirements of the ELO grant, but they are not addressed in this plan. Adherence to these requirements will be monitored through the annual audit process.

- The LEA must use at least 85 percent (85%) of its apportionment for expenditures related to providing in-person services in any of the seven purposes described above.
- The LEA must use at least 10 percent (10%) of the funding that is received based on LCFF entitlement to hire paraprofessionals to provide supplemental instruction and support through the duration of this program, with a priority for full-time paraprofessionals. The supplemental instruction and support provided by the paraprofessionals must be prioritized for English learners and students with disabilities. Funds expended to hire paraprofessionals count towards the LEAs requirement to spend at least 85% of its apportionment to provide in-person services.

- An LEA may use up to 15 percent (15%) of its apportionment to increase or improve services for students participating in distance learning or to support activities intended to prepare the LEA for in-person instruction, before in-person instructional services are offered.
