Plan Descriptions

A description of how parents, teachers, and school staff were involved in the development of the plan.

As part of the development of the Expanded Learning Opportunities Grant Plan, Panoche Elementary provided multiple opportunities for parents, students, and staff to be involved. Stakeholder engagement opportunities included:
 Panoche School Board Meetings (3/8/21, 4/12/21, 5/10/21)
 Students-School Climate Survey (April 2021)
 Parent Surveys (August 2020) (October 2020) (April 2021)
 Informal conversation with parents at daily pick up/drop off (November 2020-present)

100% of parents expressed high levels of satisfaction in regards to the ways in which the school meets student learning needs. Additionally, 86% of parents agreed that the school encourages parental involvement in school activities. Students felt that staff understands the ways in which they learn best, and that their teacher cares about them and wants them to be successful.

Areas of growth identified from all groups included campus safety and security. Additionally, student surveys indicated that students sometimes struggle with anxiety in regards to campus safety. In Fall 2020 there was a difference of opinion between staff, board, and parents regarding in-person instruction. When interviewed in August 2020, parents felt that distance learning was the best mode of instruction for most students. However, when surveyed in October 2020, the majority of parents shifted their opinion to agree that in-person instruction would be the best mode of instruction for all students.

A description of how students will be identified and the needs of students will be assessed.

Student academic needs will be identified using several different methods. All enrolled students will take the Star360 assessment in math and ELA at the beginning of the school year to establish baseline levels. Students will also take the STAR360 assessment at the end of each trimester to monitor academic progress throughout the school year. The more formative IXL assessments will also be used to assess students on specific standards and skills throughout the school year. Test results from the English Language Proficiency Assessment for California (ELPAC) and California Assessment of Student Performance and Progress (CAASPP) will also be reviewed to determine strengths and areas of growth.

Student climate will be measured three times throughout the year with a school climate survey that will be given to both students and parents. This data is used to inform the Social Emotional Learning program in place at the school.

A description of how parents and guardians of students will be informed of the opportunities for supplemental instruction and support.

Parents/guardians will be informed of the opportunities for supplemental instruction and support through personal conversation, phone calls, and letters home. Information will also be available at Back-to-School Night, during parent teacher conferences, and at other school functions. Parents will be kept apprised of current programs and activities through in person conversation and letters home. Parents will be provided with the opportunity to provide feedback during board meetings and through the School Climate Survey.

A description of the LEA's plan to provide supplemental instruction and support.

Expanded Learning Opportunity Grant funds will be used to fund the following supports:

- One Instructional Aide providing in-class support to students 5 hours weekly, with focus on intervention and academic support for unduplicated students. Compensation will also include payment for mileage to and from the school site.
- Part Time School Social Worker to support student Social-Emotional well being of all students, with focus on support for unduplicated students. Compensation will include 1 hour per month for instruction plus an additional 2 hours per month for travel time.
- Materials and supplies for enrichment in NGSS based learning, including science supply kits.

A description of how ELO Grant funds are being coordinated with other federal Elementary and Secondary School Emergency Relief Funds received by the LEA.

Panoche Elementary is also receiving IPI dollars in the amount of \$5,564. Personal Protective Equipment (PPE), cleaning and sanitizing supplies, and air filters will be purchased to ensure clean and safe facilities are provided for in-person learning. In addition, windows and

sliding doors in the classroom area will be re-screened to ensure appropriate levels of ventilation. As technology becomes obsolete and/or student enrollment increases, additional laptops and hotspots will be purchased to ensure students and staff have stable internet access and appropriate technology.

Expanded Learning Opportunities Grant Plan Instructions: Introduction

The Expanded Learning Opportunities Grant Plan must be completed by school districts, county offices of education, or charter schools, collectively referred to as Local Educational Agencies (LEAs), that receive Expanded Learning Opportunities (ELO) Grant funds under California *Education Code (EC)* Section 43521(b). Instructions: Plan Requirements

An LEA receiving ELO Grant funds under *EC* Section 43521(b) is required to implement a learning recovery program that, at a minimum, provides supplemental instruction, support for social and emotional well-being, and, to the maximum extent permissible under the guidelines of the United States Department of Agriculture, meals and snacks to, at a minimum, students who are included in one or more of the following groups:

- low-income,
- English learners,
- foster youth,
- homeless students,
- students with disabilities,
- students at risk of abuse, neglect, or exploitation,
- disengaged students, and
- students who are below grade level, including, but not limited to, those who did not enroll in kindergarten in the 2020–21 school year, credit-deficient students, high school students at risk of not graduating, and other students identified by certificated staff.

For purposes of this requirement

- “Supplemental instruction” means the instructional programs provided in addition to and complementary to the LEAs regular instructional programs, including services provided in accordance with an individualized education program (IEP).
- “Support” means interventions provided as a supplement to those regularly provided by the LEA, including services provided in accordance with an IEP, that are designed to meet students’ needs for behavioral, social, emotional, and other integrated student supports, in order to enable students to engage in, and benefit from, the supplemental instruction being provided.
- “Students at risk of abuse, neglect, or exploitation” means students who are identified as being at risk of abuse, neglect, or exploitation in a written referral from a legal, medical, or social service agency, or emergency shelter.

EC Section 43522(b) identifies the seven supplemental instruction and support strategies listed below as the strategies that may be supported with ELO Grant funds and requires the LEA to use the funding only for any of these purposes. LEAs are not required to implement each supplemental instruction and support strategy; rather LEAs are to work collaboratively with their community partners to identify the

supplemental instruction and support strategies that will be implemented. LEAs are encouraged to engage, plan, and collaborate on program operation with community partners and expanded learning programs, and to leverage existing behavioral health partnerships and Medi-Cal billing options in the design and implementation of the supplemental instruction and support strategies being provided (*EC* Section 43522[h]).

The seven supplemental instruction and support strategies are:

1. Extending instructional learning time in addition to what is required for the school year by increasing the number of instructional days or minutes provided during the school year, providing summer school or intersessional instructional programs, or taking any other action that increases the amount of instructional time or services provided to students based on their learning needs.
2. Accelerating progress to close learning gaps through the implementation, expansion, or enhancement of learning supports including, but not limited to, any of the following:
 - a. Tutoring or other one-on-one or small group learning supports provided by certificated or classified staff.
 - b. Learning recovery programs and materials designed to accelerate student academic proficiency or English language proficiency, or both.
 - c. Educator training, for both certificated and classified staff, in accelerated learning strategies and effectively addressing learning gaps, including training in facilitating quality and engaging learning opportunities for all students.
3. Integrated student supports to address other barriers to learning, such as the provision of health, counseling, or mental health services, access to school meal programs, before and after school programs, or programs to address student trauma and social-emotional learning, or referrals for support for family or student needs.
4. Community learning hubs that provide students with access to technology, high-speed internet, and other academic supports.
5. Supports for credit deficient students to complete graduation or grade promotion requirements and to increase or improve students' college eligibility.
6. Additional academic services for students, such as diagnostic, progress monitoring, and benchmark assessments of student learning.
7. Training for school staff on strategies, including trauma-informed practices, to engage students and families in addressing students' social-emotional health needs and academic needs.

As a reminder, *EC* Section 43522(g) requires that all services delivered to students with disabilities be delivered in accordance with an applicable IEP.

Fiscal Requirements

The following fiscal requirements are requirements of the ELO grant, but they are not addressed in this plan. Adherence to these requirements will be monitored through the annual audit process.

- The LEA must use at least 85 percent (85%) of its apportionment for expenditures related to providing in-person services in any of the seven purposes described above.
- The LEA must use at least 10 percent (10%) of the funding that is received based on LCFF entitlement to hire paraprofessionals to provide supplemental instruction and support through the duration of this program, with a priority for full-time paraprofessionals. The supplemental instruction and support provided by the paraprofessionals must be prioritized for English learners and students with disabilities. Funds expended to hire paraprofessionals count towards the LEAs requirement to spend at least 85% of its apportionment to provide in-person services.

- An LEA may use up to 15 percent (15%) of its apportionment to increase or improve services for students participating in distance learning or to support activities intended to prepare the LEA for in-person instruction, before in-person instructional services are offered.
