Plan Descriptions

A description of how parents, teachers, and school staff were involved in the development of the plan.

Parents were involved with development of the plan by a survey asking if they would be interested in a proposed summer school program for their students who showed learning loss of the covid 19 pandemic. Parents responded by handing in the surveys, which allowed the Superintendent to go to the Board of Trustees on April 8, 2021 and ask for their approval of a summer school program at Tres Pinos Elementary. At the monthly staff meeting on March 24, 2021, the staff were informed of the SB86 funds and if they were interested in teaching summer school. Of the 4 teachers, 3 were very interested in the summer school program. At this point, the Superintendent posted on Edjoin for summer school teachers and received 5 applications.

A description of how students will be identified and the needs of students will be assessed.

Students will be identified through i-ready test scores from our third benchmark of the year. If students are two or more grade levels below, they will be required to attend summer school session. Also, any students who want to come to summer school will be welcomed for the 4 hour a day program.

Parents and guardians will be informed of the plan through Thrillshare and our monthly newsletter. Thrillshare is a communication program that texts or e-mails parents of any school information. Also, a monthly newsletter will be given out with the information about the summer school program, any supplemental instruction, and support. Tres Pinos Elementary is also looking into after school tutorial for our students who need support and guidance.

A description of the LEA’s plan to provide supplemental instruction and support.

We will start our plan with Summer School for the 2020/2021 school year. It will begin June 22 through July 15th. The program will be 4 days a week, Monday through Thursday from 8:00 a.m. to 12:00 noon. Students will pick up their bag lunches and leave the campus. The program will be for grades 1st – 8th grade students from Tres Pinos Elementary. The next part of our plan will be to secure a tutorial program after school for the 2021/2022 school year from the YMCA. Students will be allowed to stay after school for 1 hour to receive support in academics. We will also be adopting a new NGSS science program that will be available to all students at home as well as at school for instructional needs.

A description of how ELO Grant funds are being coordinated with other federal Elementary and Secondary School Emergency Relief Funds received by the LEA.

All funds will be used for extended instructional time with Summer School, Interventions for Language Arts and Mathematics and an after school tutorial for all students will begin in the 2021/2022 school year. Hiring of a paraprofessional I for the 2021/2022 school year will also be implemented to support students such as Foster Youth, Homeless, Special Needs and English Learners with their academics. The adoption of a new on-line NGSS Science Curriculum will be included for students to access the curriculum from home and at school digitally. Professional development for staff members will be included with science curriculum and other supplemental curriculum that will be purchased. The District is investigating an after school program with YMCA for academic support for the upcoming 2021/2022 school year.

Expanded Learning Opportunities Grant Plan Instructions: Introduction

The Expanded Learning Opportunities Grant Plan must be completed by school districts, county offices of education, or charter schools, collectively referred to as Local Educational Agencies (LEAs), that receive Expanded Learning Opportunities (ELO) Grant funds under California *Education Code (EC)* Section 43521(b). Instructions: Plan Requirements

An LEA receiving ELO Grant funds under *EC* Section 43521(b) is required to implement a learning recovery program that, at a minimum, provides supplemental instruction, support for social and emotional well-being, and, to the maximum extent permissible under the guidelines of the United States Department of Agriculture, meals and snacks to, at a minimum, students who are included in one or more of the following groups:

- low-income,
- English learners,
- foster youth,
- homeless students,
- students with disabilities,
- students at risk of abuse, neglect, or exploitation,
- disengaged students, and
- students who are below grade level, including, but not limited to, those who did not enroll in kindergarten in the 2020–21 school year, credit-deficient students, high school students at risk of not graduating, and other students identified by certificated staff.

For purposes of this requirement

- “Supplemental instruction” means the instructional programs provided in addition to and complementary to the LEAs regular instructional programs, including services provided in accordance with an individualized education program (IEP).
- “Support” means interventions provided as a supplement to those regularly provided by the LEA, including services provided in accordance with an IEP, that are designed to meet students’ needs for behavioral, social, emotional, and other integrated student supports, in order to enable students to engage in, and benefit from, the supplemental instruction being provided.

- “Students at risk of abuse, neglect, or exploitation” means students who are identified as being at risk of abuse, neglect, or exploitation in a written referral from a legal, medical, or social service agency, or emergency shelter.

EC Section 43522(b) identifies the seven supplemental instruction and support strategies listed below as the strategies that may be supported with ELO Grant funds and requires the LEA to use the funding only for any of these purposes. LEAs are not required to implement each supplemental instruction and support strategy; rather LEAs are to work collaboratively with their community partners to identify the supplemental instruction and support strategies that will be implemented. LEAs are encouraged to engage, plan, and collaborate on program operation with community partners and expanded learning programs, and to leverage existing behavioral health partnerships and Medi-Cal billing options in the design and implementation of the supplemental instruction and support strategies being provided (*EC* Section 43522[h]).

The seven supplemental instruction and support strategies are:

1. Extending instructional learning time in addition to what is required for the school year by increasing the number of instructional days or minutes provided during the school year, providing summer school or intersessional instructional programs, or taking any other action that increases the amount of instructional time or services provided to students based on their learning needs.
2. Accelerating progress to close learning gaps through the implementation, expansion, or enhancement of learning supports including, but not limited to, any of the following:
 - a. Tutoring or other one-on-one or small group learning supports provided by certificated or classified staff.
 - b. Learning recovery programs and materials designed to accelerate student academic proficiency or English language proficiency, or both.
 - c. Educator training, for both certificated and classified staff, in accelerated learning strategies and effectively addressing learning gaps, including training in facilitating quality and engaging learning opportunities for all students.
3. Integrated student supports to address other barriers to learning, such as the provision of health, counseling, or mental health services, access to school meal programs, before and after school programs, or programs to address student trauma and social-emotional learning, or referrals for support for family or student needs.
4. Community learning hubs that provide students with access to technology, high-speed internet, and other academic supports.
5. Supports for credit deficient students to complete graduation or grade promotion requirements and to increase or improve students' college eligibility.
6. Additional academic services for students, such as diagnostic, progress monitoring, and benchmark assessments of student learning.
7. Training for school staff on strategies, including trauma-informed practices, to engage students and families in addressing students' social-emotional health needs and academic needs.

As a reminder, *EC* Section 43522(g) requires that all services delivered to students with disabilities be delivered in accordance with an applicable IEP.

Fiscal Requirements

The following fiscal requirements are requirements of the ELO grant, but they are not addressed in this plan. Adherence to these requirements will be monitored through the annual audit process.

- The LEA must use at least 85 percent (85%) of its apportionment for expenditures related to providing in-person services in any of the seven purposes described above.
- The LEA must use at least 10 percent (10%) of the funding that is received based on LCFF entitlement to hire paraprofessionals to provide supplemental instruction and support through the duration of this program, with a priority for full-time paraprofessionals. The supplemental instruction and support provided by the paraprofessionals must be prioritized for English learners and students with disabilities. Funds expended to hire paraprofessionals count towards the LEAs requirement to spend at least 85% of its apportionment to provide in-person services.
- An LEA may use up to 15 percent (15%) of its apportionment to increase or improve services for students participating in distance learning or to support activities intended to prepare the LEA for in-person instruction, before in-person instructional services are offered.
