- A. It is recommended that the Board, in the manner as more fully set forth in the Board Resolution presented this evening, the full text of which is incorporated into this Motion by specific reference, grant a leave of absence for medical reasons for Dr. Jeffrey Zwiebel, which leave may continue indefinitely through the end of his present appointment April 5, 2021 and subject to his continuing need for leave supported by medical verifications as per Board Policy.

- B. It is recommended that the Board in the manner as more fully set forth in the Board Resolution presented this evening, the full text of which is incorporated into this Motion by specific reference, appoint Jared A. Gerace, Ed.D. as Substitute Superintendent during the absence of Superintendent Zwiebel. Dr. Gerace's title shall be "Acting Superintendent" and he shall be vested with full authority to act as Superintendent of Schools. Dr. Gerace's appointment shall be effective immediately. His salary while Acting Superintendent shall be based on an annualized prorated salary of \$112,000.00, subject to review and adjustment as the Board deems appropriate.

It is recommended that the Board in the manner as more fully set forth in the Board Resolution presented this evening, the full text of which is incorporated into this Motion by specific reference, to approve such other administrative appointments as set forth in the Resolution including appointing Mrs. Caitlin R. Mohl as Acting Middle School Principal during the absence of Superintendent Zwiebel and appointing Mr. Michael Maley as Acting Elementary Principal during the absence of Superintendent Zwiebel. Mrs. Mohl shall be vested with full authority to act as Middle School Principal. Mr. Maley shall he shall be vested with full authority to act as Elementary Principal. Mrs. Mohl's salary while Acting Middle School Principal will be based on an annualized prorated salary of \$92,000.00. Mr. Maley's salary while Acting Elementary Principal will remain at his current salary.
