

SECOND AMENDMENT TO ADDENDUM TO THE REGULAR TEACHER CONTRACT BETWEEN MARY TRACY-MACAULAY AND THE HANOVER COMMUNITY SCHOOL CORPORATION BOARD OF SCHOOL TRUSTEES

WHEREAS, the Board of School Trustees for the Hanover Community School Corporation (“Board”) and Dr. Mary Tracy-MacAulay (“Superintendent”) entered into an Addendum to the Regular Teacher Contract Between Mary Tracy-MacAulay and the Hanover Community School Corporation Board of School Trustees on September 28, 2022, to employ Dr. Tracy-MacAulay as Superintendent of Hanover Community School Corporation (the “Contract”); and

WHEREAS, the Board and Superintendent entered into a First Amendment to Addendum to the Regular Teacher Contract Between Mary Tracy-MacAulay and the Hanover Community School Corporation Board of School Trustees on September 12, 2023, amending the salary of the Contract (“First Amendment”); and

WHEREAS, it is in the mutual best interest of the parties for the Board to continue to employ the Superintendent and the Superintendent to continue in the employ of the Board; and

WHEREAS, the Contract, by its agreed upon terms, affords the parties the opportunity to modify the provisions of the Contract in writing; and

WHEREAS, the parties have reached an agreement related to modifications of the Contract and desire to enter into this Second Amendment to Addendum to the Regular Teacher Contract Between Mary Tracy-MacAulay and the Hanover Community School Corporation Board of School Trustees (“Second Amendment”).

NOW THEREFORE, come the parties to stipulate and agree to the modification of the relevant terms of the Contract and First Amendment, as follows:

1. Section 1, Basic Salary & Benefits: Retroactive to July 1 2024, for each period from July 1 to the following June 30 (hereafter in this Contract referred to as a "school year"), the Superintendent shall be paid a basic salary of One Hundred Fifty-Six Thousand Three-Hundred Five Dollars and Twenty-Six Cents (\$156,305.26).


2. Except as modified by the terms of this Second Amendment, the other terms and conditions of the Contract and First Amendment shall remain in full force and effect.


