Mandatory Fees



For **returning and all ECC students**, the non-refundable \$1,000 deposit is applied to tuition. For new students in grades 1 through 12, the non-refundable \$1,000 deposit is applied to a one-time matriculation fee.

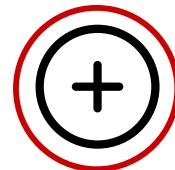

Tuition Payment Plans

Tuition payments can be made in installments through two payment plans: Semi-Annual or Monthly (9 months - June - February) for an additional fee. The administrative charge for installment payment plans are due in July. This charge covers the cost of extending the payment plan, and includes, but is not limited to fees charged by third-party processors and a portion of the Tuition Refund Plan.

- Fee for Semi-Annual Plan: \$250
- Fee for Monthly Plan: \$550

VC Pay



Carrollwood Day School now uses **VC Pay** for billing and payments of tuition and fees. Every family will be required to enter their payment information in the re-enrollment/enrollment portal to activate your VC Pay account. TOTAL TUITION - PAYMENT PLAN OPTIONS 2024-2025

As a convenience, parents can pay tuition in installments through two payment plans: Semi Annual or Monthly (9 months - June through February) for an additional fee. The administrative charge for installment payment plans are due in July.

Carrollwood Day School uses **VC Pay** for billing and payments of tuition and fees (with the exception of lunch). Parents are required to set up and maintain a VC Pay account for all payments. CDS cannot accept payments in cash; payments must be made by EFT (Electronic Funds Transfer) from a checking or savings account (no convenience fee), or by credit card (subject to a 2.85%-2.95% (AMX) convenience fee) directly to VC Pay. Personal check, cashier's check, bank check, and money order accepted only for lump sum or full tuition payments.

Late Fees: Parent understands and agrees that a late charge of 1.5% per month (i.e., 18% per annum) will be added for any delinquent payment (*which is defined as a payment not received within 10 days after the due date*). In addition, a fee of \$30.00 or actual bank fee (*whichever is higher*) will be charged on any returned check or any ACH payment that cannot be processed. In the event of default (*default being 30 days past due*) Parent agrees to pay all costs of collection, including collection agency fees, attorneys' fees, court costs and interest of 1.5% per month. Further, as to any account more than 90 days in arrears, the School reserves the right to accelerate the total unpaid balance of tuition and fees due under this Enrollment Contract. After accounts are more than 90 days in arrears, the account will be referred to the School's collection agent and/or counsel for satisfaction.
