LFHS will hold an annual meeting to explain Title I requirements and Parents' Right-to-Know. Parents were invited through multiple sources, including the school's Facebook page, the school website, Remind, Blackboard Messenger Calls, and letters. The meeting was held at the school early in the fall semester to allow the maximum amount of participation and impact.

LFHS will use Blackboard Messenger, Facebook, and Remind to address parents in a timely manner and to remind or invite them to important events. The school will also maintain a website that informs parents of events. A small number of students are identified as EL students at our school, but translation services are used for any written communication that is sent home. Schoology and PowerSchool parent portal will allow parents to access classroom assessment information. In addition, teachers will communicate classroom expectations through syllabi, letters, e-mails, or web pages. Also, teachers will use the 'Remind' app to communicate with parents the certain expectations and due dates within the classroom. The administration will also use social media to communicate with parents about opportunities for participation in school events.

Individual parent conferences will allow further opportunities to discuss a child's academic achievement, the standards being tested, and the assessment itself. The Media Specialist periodically offers workshops to help orient parents to Schoology and the suite of Google Apps for Education and how they are used to educate and engage the students of LFHS. Senior parents are invited to a Senior Year Boot Camp and offered assistance with the FAFSA. The counselor also sends out student support emails and scholarship resources to parents.

Teachers are provided the Remind tool for primary contact with students. They also utilize telephone calls and emails. All teachers know which students require translated documents for home contact. LFHS parents are very actively engaged in school athletic teams and events. Administrators, teachers, and staff are working to increase parent engagement on an academic level and meet the athletic engagement level. LFHS is a member of Cohort 10 of the A+ College Ready program and, in doing so, has increased the level of rigor in our classrooms. Although the grant has ended, we still serve as a partner school. The jump in expectations has helped engage parents in a more academic-focused conversation. All school personnel are encouraged to communicate with parents as often as possible.
