The following are descriptions of school attendance zones for this District.

New Bradford Elementary: In the City of Starke, from the intersection of the centerlines of State Road 301 (S/N Temple Avenue) and State Road 100 (W. Madison St.) run north on the centerline of State Road 301 (Temple Avenue) to the intersection of the centerlines of State Road 301 and Weldon Street, head east on the centerline of E. Weldon Street to the intersection of the centerline of E. Weldon and North Water Street, head northeast on the centerline of N. Water Street to the intersection of the centerline of N. Water Street and North Street, then due east along the centerline of North Street to the intersection of the centerline of the centerline of the centerline of N. Water Street to the intersection of the centerline of Street to the intersection of the centerline of Street to the intersection of the centerline of North Street and Old Lawtey Road, then due south to the intersection of the centerlines of Old Lawtey Road and State Road 16, then east along the centerline of State Road 16 to the Bradford County Boundary.

Head due south on the Bradford County border through Keystone Airport, along the County Boundary through Lake Bedford and Lake Geneva to the intersection of the Bradford County boundary and State Road 21, south on the centerline of SE 22nd Avenue and west along the Bradford County Boundary and parcel boundaries of Santa Fe Lake and Little Santa Lake.

Zone continues to follow the Bradford County boundary line west to Worthington Springs and northeast along the Bradford County boundary and New River centerline then centerline of Lake Butler-to-Palatka Trail. Continue southeast along the centerline of the Lake Butler-to-Palatka Trail through New River and continue to the merge of the Lake Butler-to Palatka Trail and SW County Rd 225 and the Sampson River. Follow the centerline of the Sampson River northeast to the intersection of the river and shoreline sections of the parcels fronting Sampson Lake. Zone continues east along the southern shoreline of Lake Sampson and encompasses the community to the south accessed by 137th Street. At the NE corner of Parcel #008-30000-101, continue south on the western border of said parcel to the centerline of the CSX right-of-way, parcel #063-010-0000.

Continue northeast on the centerline of the CSX right-of-way to intersection of the CSX right-of-way and the State Route 301 Stark Bypass and continue north along the centerline of State Road 301 Starke Bypass to the intersection of State Road 301 Starke Bypass and State Route 100. Continue east along the centerline of State Road 100 to the point of beginning, the centerline of State Road 301/Temple Avenue and State Route 100.

Starke Elementary: From the point origin, the intersection of the centerlines of State Route 16 and the New River and Bradford County Boundary, head southeast on the centerline of State Route 16 to the intersection of the centerlines of State Route 16 and NW County Road 225 then head east on the centerline of NW County Road 225. At the intersection of the centerlines of County Road 225 and NW 53rd Avenue, head south on the centerline to the intersection of NW 53 rd Avenue and the northward continued boundary of parcel 018-010-0000 or the western boundary of the parcel west of the centerline of NW 51st Lane. Continue south on the western boundary of parcel 018-010-0000, continue south on the boundary between Parcel 018-170-0200 and Parcel 018-040-0000, continue south across the centerline of Water Oak Creek to the SW corner of Parcel 018-060-0000. Continue east on the southern boundary of Parcel 018-060-0000 to the point of intersection between Parcel 018-420-0000 and Parcel

018-510-0100. Continue south on the parcel boundary to the intersection of the SE corner of Parcel 018-420-0000 and the NE corner of Parcel 018-420-0500. Follow the boundary of Parcel 018-420-0000 and Parcel 018-420-0500 west to the centerline of the right-of-way of NW 52 nd Avenue. Head south on the centerline of NW 52nd Avenue to the intersection of the centerline of NW 52 nd Avenue and NW

216th Street.

Head southwest on the centerline NW 216th Street to the intersection of NW 216^{fr} Street and the western boundary ofT06S R22E Section 32. Head south along the western boundary of T06S R22E Section 32 to the SW corner ofT06S R22E Section 32. Continue east along the southern boundary of T0GS R22E Section 32, TOSS R22E Section 33, and T05S R22E Section 34, cross U.S. Highway 301, continue to the intersection of the centerlines of the CSX right of way (parcel #063-010-0000) and NE 204th Street. Continue southwest along the CSX right of way to the northern boundary of T06S R22E Section 10. Head east on the northern boundary of T06S R22E Section 10, T0GS R22E Section 11, and T06S R22E Section 12 (or the eastern continuation of NW County Road 223 across State Highway 301) to the Bradford County Boundary.

Continue south along the Bradford County Boundary to the intersection of the centerline of State Route 16, the eastern boundary ofT06 R22E, and the western boundary of T06R23E. Head west on the centerline of State Road 16 to the intersection of the centerlines of State Route 16 and Old Lawtey Road in the City of Starke, FL. Head north on the centerline of Old Lawtey Road to the intersection of the centerlines of North Street and Old Lawtey Road. Head west on the centerline of North Street to the intersection of the centerlines of North Water Street and North Street. Head south on the centerline of North Water Street to the intersection of the centerline of East Weldon Street. Head west on the centerline of E Weldon Street to the intersection of W Weldon Street and U.S. Highway 301/ N. Temple Avenue. Head south on the centerline of IJ.S. Highway 301/ South Temple Avenue to the intersection of the centerlines of West Madison Street and U.S. Highway 301/ South Temple Avenue.

Continue west along the centerline of State Road 100 to the intersection of State Road 301 Starke Bypass and State Route 100. Continue south on the centerline of State Route 301 Starke Bypass to the intersection of the centerlines of CSX right-of-way (parcel #063-010-0000) and the State Route 301 Stark Bypass. Continue southwest on the centerline of the CSX right-of-way to intersection of the continuation of the eastern boundary of parcel#008-3000-0101. Continue northwest to the SE corner of parcel# 0083000-0101 and north on the eastern boundary to the northeast corner of parcel# 008-3000-0101. Zone continues west along the shoreline of Lake Sampson and encompasses the community to the south accessed by 137th Street.

Follow shoreline sections of the parcels fronting Sampson Lake to the intersection of the centerline of the Sampson River. Continue southwest along the centerline of Sampson River to the merge of the Lake Butler-to Palatka Trail and SW County Rd 225 and the Sampson River. Zone continues to follow the Lake Butler-to Palatka Trail northwest to the intersection of the centerlines of Bradford County Boundary and Lake-Butler-to-Palatka Trail.

Follow the Bradford County Boundary to the point of beginning, the intersection of the centerlines of State Route 16 and the New River and Bradford County Boundary.

Lawtey Elementary: From the point of origin, the intersection of the centerlines of State Route 16 and the New River and Bradford County Boundary, head northeast along the Bradford County line (centerline of the New River) to the intersection of the Bradford County boundary, the New River and the northern boundary ofT04S R22E Section 19, then eastward along the northern boundary of T04S R22E, crossing NW 127th Avenue, to the intersection of the NE corner of T04S R22E Section 24 the northwest corner ofT04S R23E Section 19. Continue southward along the Bradford County line (western boundary ofT04S R23E, eastern boundary of T04S R22E), crossing U.S. Highway 301/State Road 200 in Highland and continuing southward along the border of Joint Training Base Camp Blanding, crossing the

County Road 225 right of way, and just south to the intersection of the northeast corner of T06 R22E Section 12, the northwest corner ofT06 R23E Section 07. Continue westward on the northern boundary of T06S R22E Sections 11-12 and TOSS R22E Section 10 to the intersection of TOGS R22E Section 10 and the centerline of the CSX right of way. Continue northeast on the centerline of the CSX right of way (Parcel #063-010-0000) to the intersection of NE 204th St and the centerline of CSX right of way. Continue west on the northern boundary of T06 R22E Section 03, crossing U.S. Highway 301 and continuing west on the northern boundary ofT06S R22E Section 04 and T06 R22E Section 05 to the northwest corner of T06 R22E Section 05.

Head north along the western boundary of TO6S R22E Section 32 to the intersection of the centerline of NW 216th Street and the western boundary of T06S R22E Section 32. Continue east on the centerline of NW 216th Street to intersection of the continuance of the right-of-way of NW 52nd Avenue and NW 216th Street. Head north on the centerline of NW 52nd Avenue to the southeastern parcel boundary of parcel #018-420-0000 to the intersection of the boundary of parcel #018-510-0100. Continue north on the western boundary of parcel #018-510-0100 to the southern boundary of parcel 018-600-0000 (southern boundary of T05SR22E. Zone continues west on the southern boundary of parcel 018-600-0000 (southern boundary of T05SR22E) to the intersection of the SW corner of parcel 018-600-0000, the SW corner of T05S R22E Section 29, and the SE corner of T05S R22E Section 30. From the SE corner of T05S R22E Section 30, continue north on the eastern boundary of TOSS R22E Section 30 and the western boundary of T05S R22E Section 29, crossing Water Oak Creek, to the centerline of NW 219th St. From the intersection of the eastern boundary of TOSS R22E Section 30, continue west and north on the centerline of the NW 53rd Avenue right of way to the intersection of the centerline of NW County Road 225 and NW 53rd Avenue. From the intersection of the centerlines of NW County Road 225 and NW 53rd Avenue, follow the centerline of NW County Road 225 west to the intersection of the centerlines of State Road 16 and NW County Road 225, then northwest on the centerline of State Road 16 to the point of beginning.
