Council Items- The meeting was called to order by Mr. Caldwell at 4:21 p.m.

1. Review of the Agenda – A motion was made by Mary Reed to approve the Agenda. It was seconded by Sondra Esposito and approved by consensus.
2. Approval of July Draft Minutes – A motion was made Heather Dremov to approve the Draft Minutes. It was seconded by Kristen Brown and approved by consensus.
3. Council Action and Review Items.
 - a. Science Curriculum pilot. Mr. Caldwell explained the new Science Curriculum pilot that will be introduced across all middle schools. The Curriculum is cost free and the District will be purchasing the lab equipment.
 - b. ELA Curriculum pilot. Mr. Caldwell mentioned exploring the possibility of piloting EL Curriculum. If we did decide to do so we would have to have a process set in place since we would need to consider multi grade levels, new teachers, etc. It would be beneficial to have a committee. There are a couple different ELA options that the elementary and high schools are using.
4. Principal Update.
 - a. Update on Master Schedule. Mr. Caldwell notified Council that we were able to finally put a teacher name on every section of our Master Schedule.
 - b. Studer Survey Action Plan. Mr. Caldwell said the survey is done in the Spring. We receive results during the Summer. We get to gather information from students, staff and parents. It gives us a good all-inclusive perspective.
 - c. Consultation on Personnel Actions. Closed session to discuss personnel selection as per KRS 61.810(1)(f). At 11:15 a.m. Mr. Caldwell took the Council into closed session to discuss Personnel at 5:30 p.m. He reopened the meeting at 5:46 p.m.

d. 23-24 CSIP Goals. Mr. Caldwell explained the different phases of CSIP to Council. He said KSA scores may be back by the end of September. He explained that iReady helps prepare students for the KSA testing. He also discussed the Achievement Gap.
