<p>How can a parent help their child learn and make progress?</p>	<p>Active involvement in your child's education is crucial for their learning journey. Ask your child about their school day regularly to discuss the topics and assignments they are currently working on.</p> <p>Connect with their teachers to gain insights into your child's progress and inquire about ways to support their learning. Attend various school events to stay connected and learn more about how to assist your child.</p> <p>Create a dedicated space at home for homework and studying, if possible, and encourage a reading culture by modeling reading behavior. Discuss your child's progress and efforts, being an engaged participant in their education. Maintain open communication with your child's teacher and keep a diverse range of books at home to encourage reading at different levels.</p> <p>Utilize local resources such as homework assistance and refer to parent guides for academic standards. These guides provide information to help parents understand the North Carolina Standard Course of Study and offer practical strategies for implementation at home.</p> <p>Explore reading and literacy support resources, including the mCLASS® Home Connect - Parent Resources, which offers materials for families to practice crucial literacy skills. Additionally, North Carolina's Digital Children's Reading Initiative (DCRI) provides home activities, printables, and games covering various literacy topics for Pre-K through Grade 5. How can a parent help their child develop citizenship, social skills and respect for others?

Project-Based Learning (PBL) is the chief learning technique used at our school. PBL meets the academic standards while also teaching skills such as: Critical Thinking, Collaboration, Teamwork, Leadership, Self-Initiative and Motivation, Integrity, Perseverance, Courage, and Self-Control. By using PBL students are able to integrate many skills on a daily basis to help them build strong personal character. As additional support for our students, we subscribe to an Honor Code that all students are expected to meet. This helps to hold all students accountable to high standards and expectations.

Falls Lake Academy subscribes to a social and emotional learning program that provides interactive lessons each week for every student. These lessons reinforce building good moral character.

To keep parents informed of school events and student growth, the school communicates often with parents through email newsletters, telephone calls, and individual and group meetings.</p>

Falls Lake Academy uses a range of events and communications vehicles to share information with parents and give them opportunities to offer feedback. This includes:

- Newsletters: The school publishes a newsletter monthly for families to provide updates on current events and programmatic developments. K-8 Classrooms provide a newsletter with weekly updates.
- Social Media: The school maintains a strong, user-friendly website to give parents access to information on the school and on their children's experience at the school. The school also takes advantage of Facebook and Instagram, with the goal of further strengthening connections among school leaders, teachers, and family members.
- Classroom Communication: Teachers regularly give students information to take home to their parents. Examples include weekly updates and take-home folders with classroom-specific information. Teachers also give parents regular reports on their students' progress using letters, online communications, phone calls, texts, and/or face-to-face meetings.
- Parent Meetings/ Conferences: The school regularly schedules parent information sessions so parents can learn what their students are doing and learning in school. In addition, the teachers conduct parent teacher conferences to discuss student's academic progress with parents.
- App: In addition to using online access to their child's academic information, families can also use our app as a resource for easier access to needed materials.
- Student Information System: The school utilizes a student information system to provide families with important school information including upcoming events, school closures, messages from staff, real time grading, staff directory, and etc.
- Family Nights: We schedule various social and educational events during the school year to strengthen relationships among students, parents, teachers, and administrators.
- Parent Surveys: Each fall and spring, the school conducts parent surveys to gather feedback from parents.
- PAA: Parent Adult Advocates are assigned to every student and this person serves as the first line of contact between parents and the school.

	<p><u>Family Literacy Services</u> Literacy at Home: The Digital Children’s Reading Initiative, developed by NCDPI, presents literacy activities tailored to each grade level, spanning from pre-kindergarten through fifth grade.</p> <p><u>Mentoring</u> Mentoring services are accessible at specific schools. Parents can get in touch with their child’s school to learn more about these services.</p> <p><u>Tutoring</u> NCVPS EdVantage Tutoring provides virtual statewide comprehensive support for middle and high school students in NC public schools. Tutoring covers Math, Science, and ELA and is delivered through a personalized partnership with district/school leadership to effectively address the needs of selected students each semester. Tutoring services are offered at certain schools. Parents can contact their child’s school to obtain information about these services.</p>

What are the rigorous academic programs available to my child? How can I learn more about them?

Falls Lake Academy offers a variety of options for students to pursue their interests, skills at their academic level.

Career and Technical Education (CTE)

Falls Lake Academy has made a significant investment in developing students and programs to meet the needs of the future workforce. Through Career and Technical Education (CTE) programs, our school offers opportunities for students to develop career realization through Engineering and Computer Science pathways in the CTE program.

At Falls Lake Academy, there are programs available that are more rigorous and challenging than the standard content for students. They include:

Academically and/or Intellectually Gifted (AIG)

In NC, school districts must identify and serve academically or intellectually gifted (AIG) K-12 students. These are students who are performing, or have the potential of performing, at high levels of accomplishment in intellectual and/or specific academic areas, such as reading and/or math when compared with other students of their age, or in their grade level, experience, or environment. The Falls Lake Academy AIG Plan outlines specific opportunities for differentiated, rigorous instruction and accelerated programs.

Other Student Services Available

- Differentiated curriculum and instruction with flexible student groups;
- Accelerated opportunities (subject and/or grade acceleration, credit by demonstrated mastery (CDM), AP/IB/CIE courses, dual enrollment courses);
- Enrichment experiences, which may be during the school day or beyond, and may be within the regular calendar year or may include summer opportunities; and
- Other opportunities for extension of content standard.

Services for AIG students may be provided by AIG personnel or within the regular classroom by teachers trained to meet the needs of gifted students or by accredited online education programs.

Honors Level Courses

At Falls Lake Academy, students have access to a variety of honors level courses in high school. These courses are available in the [High School Course Guide](#). Honors level courses typically have a faster pace than standard level courses. They offer additional rigor, complexity and creativity than standard level courses.

Career and College Promise (CCP)

Charlotte Mecklenburg Schools offers dual enrollment opportunities through the CCP program. If your high school student qualifies, students may earn high school credit by completing community college coursework.

CCP courses may be taken in the College Transfer or Career and Technical Education pathway. These courses count for both high school and college credit. Tuition is free for families but families may be required to pay for books used in the class. For additional information please visit:

	<p><u>NCVPS</u> North Carolina Virtual Public School (NCVPS) is NC's state supplemental program and leader in online education, providing inclusive learning opportunities for students across the state. Founded in 2007, with a strong commitment to ensuring quality education for all students, regardless of location, NCVPS has over 16 years of experience serving diverse Learners.</p> <p>Students may enroll in NCVPS courses for a variety of reasons. Work with your school counselor if you are interested in taking NCVPS courses.</p> <p>Governor's School: Each summer, NC Governor's School offers a unique opportunity for high-achieving rising juniors and seniors to learn with their peers from across the state in an 4-week residential program at two college campus sites. Charter schools are public schools of choice that are authorized by the State Board of Education and operated by independent non-profit boards of directors. Influenza is a virus spread from infected persons to the nose or throat of another. Influenza can cause fever, sore throat, chills, coughs, headache, and muscle aches. A yearly vaccination is available.

Meningococcal disease is a serious illness caused by bacteria. It is an infection of the brain and spinal cord coverings and can cause blood infections. The vaccine for this is required for individuals entering 7th grade or by the age of 12.
