If you wish to address the DELAC Board, please complete a speaker card located at the entrance to the meeting room and provide it to the recording secretary at the beginning of the meeting, regardless of when you plan to speak. A person wishing to be heard by the Board shall first be called up by the board parliamentarian and shall then proceed to comment as briefly as the subject permits. Individual speakers shall be allowed three minutes to address the Board on agenda and non-agenda items for a total of 30 minutes at the beginning of each regular meeting. Individual speakers shall be allowed three minutes to address the Board on agenda items and shall limit the total time for public input on each item to 20 minutes. In order to stay within the prescribed time allotments for public input, ensure full opportunity for public input, and allow the board to proceed with its decision-making, the Board president may, with Board consent, adjust the amount of time allowed for public input and/or the time allotted for each speaker. Any such adjustment shall be done equitably so as to allow a diversity of viewpoints. The president may also ask members of the public with the same viewpoint to select a few individuals to address the Board on behalf of that viewpoint. Because of the Brown Act, neither the Board nor Administration may respond to items not on the agenda, but may ask clarifying questions only. A speaker's allotted time cannot be deferred to another speaker. If submitting comments in writing, clearly marked "Public Comment" and provide it to the recording secretary. Please note that they will not be read aloud at the meeting but will be made a part of the archived agenda documents.
