Formed in 2019, the Nassau BOCES Mental Health Consortium (MHC) united to collectively support the implementation of NYSED's Mental Health Education requirements. Now expanded, MHC embraces all 56 districts in Nassau County, alongside several districts in Suffolk and Westchester counties.

### **Collegial Circles**

The Mental Health Consortium offers 10+ collegial work groups/circles that meet virtually monthly, including, elementary counselor circle, school psychologist collaborative clinical discussion group, BCBA circle, LGTBQ+ learning group, crisis team roundtable exercises and more. These groups are offered to school district staff for NO COST.

These groups are moderated by experts in their fields. The district MHC membership covers the cost of these groups.

#### **Staff Collaboration**

MHC members use a dedicated closed listserv to communicate ideas, share initiatives, resources, and upcoming events. Managed by Nassau BOCES the MHC Listserv offers members access to mental and behavioral health, social emotional learning and NYSED initiative resources and materials PK-12.
